DIRECTIONS FOR USE

LAWNS: To control ants, chiggers, earwigs, sow bygs, cutworms, sod webworms (lawn moths), and white grubs. For ants apply 1 lb. per 1,000 square feet or contents of this bag on 5,000 square feet. Repeat as necessary to maintain control. For better control of earwigs, apply the product along the edges of cement walks, around base of trees and along edges of building foundations. For chiggers, white grubs, Japanese beetle larvae, cutworms, and sod webworms use 2 lbs. per 1,000 square feet. For beller control of chiggers and sod webworms (lawn moths) in established lawns, water the lawn before applying insecticide and do not water again for 2-3 days. For better control of subsurface feeding cutworms, white grubs and Japanese beetle larvae, lawn should be watered after application of insecticide. For new lawns, work 2 lbs. per 1,000 square feet into top 2-3 inches of soil while preparing the seed bed. Birds feeding on treated areas may be hormed.

FLOWER BEDS AND TRANSPLANTS: Work into soil at 2 lbs. per 1,000 square feet as for new turf. Sprinkle around new transplants as set out to control cutworms. Sprinkle along walls, rock borders, and sidewalk edges where ants and sowbugs tend to hide. If ants are observed around trees and shrubs subject to aphid attack, apply a barrier around base of plants (does not control aphids — spray with Acme Malathion 50% Spray for these). Make application with a tin can or sifter box.

BULBS: Protects bulbs against thrips. Before storing gladiolus, tulips sprinkle with granules and stir to coat. Remove soil and dried tops beforehand. If stored in peat moss or vermiculite mulch, sprinkle a small amount of granules over each layer as bulbs are packed.




