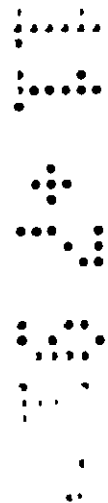

PRECAUTIONARY STATEMENTS

Hazards to Humans & Domestic Animals

Statement of Practical Treatment

IF SWALLOWED: Drink one or two glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. Get medical attention immediately.

IF INHALED: Remove victim to fresh air and apply respiration as indicated.

IF ON SKIN: Wash promptly with soap and water. Rinse thoroughly.

STORAGE & DISPOSAL

STORAGE: Store in original container in a locked storage area inaccessible to children or pets.

PESTICIDE DISPOSAL: Securely wrap original container in several layers of newspaper and discard in trash.

CONTAINER DISPOSAL: Do not reuse container. Rinse thoroughly before discarding in trash.

In extreme cold, crystals may form. Warm to about 80F to redissolve. Shake bottle to remix contents prior to measuring.

POTATOES: To control leafhoppers, flea beetles and Colorado potato beetles, use 1 TBS. per gallon of water per 150 feet of row. Do not use more than 1 quart of product per 1/4 acre. Spray as soon as insects appear. Repeat at 10-day intervals. Do not feed treated foliage to animals.

FLIES AND MOSQUITOES: A residual spray for house flies, stable flies and mosquitoes. To make a 5% dilution add 1 quart of this

product to 1 1/2 gallons of water. Apply 1 gallon of mixed spray per 1000 sq. ft. or to runoff point. Spray areas where insects are known to congregate such as farm buildings and barnyards, particularly around windows, doors, porches and garbage cans. Do not use in milk houses or in poultry houses. If used in barns, all animals should be removed and all feed troughs, pans or drinking equipment covered. Do not apply to animals. Do not apply this concentration to foliage as injury may result.
