READ THE LABEL CAREFULLY, DO NOT EXCEED DOSAGE, DO NOT USE INSIDE THE HOME. Use only as specified on this label.

CHINCH BUGS, SOD WEBWORMS, EARWIGS, CUTWORMS, AND ANTS IN TURF AND GRNAMENTAL LAWNS: Mix 1½ fl. ozs. (3 tbs.) in 20 gallons rated sprayer. Dilute to mark with water. Apply uniformly to 1,000 sq. ft. area, or 4 tsp. per 15 gallons for 500 sq. ft.

Measure area to be treated. For best results lawn should be well watered before spraying. Treat as soon as insects appear. Repeat only if needed. Thorough wetting is necessary for chinch-bug control.

TO* PREVENT ANTS, CRICKETS, EARWIGS, SOWBUGS, BROWN DOG TICKS, AND WATERBUGS (woods roaches) FROM INFESTING BUILDING: Spray a band 6 to 10 feet wide around the building including 2 feet up the foundation. Use same dosage and dilution as recommended above.

MEALYBUGS, CUTWORMS, AND LEAFHOPPERS ON ORNAMENTAL PLANTS: Mix 6½ tbs. in 10 gailons of water. Use a suitable hand sprayer and apply uniformly, but not to the point of excessive runoff. Treat when pests appear and repeat at 7 to 10 day intervals if needed. Mosquitoes resting in sprayed shrubbery will be killed for several days.

NOTE: Do not use on azaleas, camellias, poinsettias, rose bushes. or variegated ivy because of possible injury to these plants
