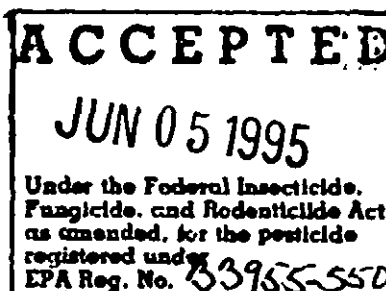

PRECAUTIONARY STATEMENTS

Hazards to Humans & Domestic Animals:

Statement of Practical Treatment

IF SWALLOWED: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.

IF ON SKIN: In case of contact, remove contaminated clothing and immediately wash skin with plenty of soap and water.

IF IN EYES: Flush eyes with plenty of water.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine only by injection is an antidote.

Environmental Hazards: This product is toxic to fish, birds, and other wildlife. Do not apply directly to water. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from treated areas. Do not contaminate water by cleaning of equipment or disposal of wastes.

STORAGE & DISPOSAL

STORAGE: Store in original container and place in locked storage area away from children, pets, food, and feedstuffs. Keep from freezing. Do not store below 32° F.

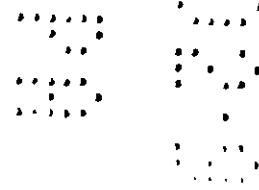
PRODUCT DISPOSAL: Securely wrap original container in several layers of newspaper and discard in trash.

CONTAINER DISPOSAL: Do not reuse container. Rinse thoroughly before discarding in trash.

- RESIDENTIAL BUILDINGS -

Homes, Apartments & Nonfood Areas of Industrial, Institutional and Commercial Buildings, including Hospitals, Stores, Manufacturing Plants and Warehouses: For Spot Treatment Only — Apply as a coarse spray to localized areas where cockroaches, ants, clover mites, crickets, firebrats, silverfish and spiders are found or normally occur including dark corners of rooms and closets; cracks and crevices in walls; along and behind baseboards; beneath and behind sinks, stoves, refrigerators and cabinets; around plumbing and other utility installations. For ants, apply to ant trails and around doors and windows and wherever else these pests may find entrance. NOTE: A period of 4 to 7 days is normally required for maximum effect on cockroaches.

Carpet Beetles: Thoroughly apply as a spray for spot treatment along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever these insects are seen or suspected.



Fleas & Brown Dog Ticks: Thoroughly apply as a spray for spot treatment to infested areas such as pet beds and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet area. Do not treat pets with this product. To control the source of flea infestation, pets inhabiting the treated premises should be treated with Acme Garden Guard 1% Rotenone or Acme Sevin Brand Carbaryl Insecticide 5% Dura-Dust, both registered for direct application use to dogs and cats. Observe all precautions on this label.

- PESTS OUTDOORS -

Flies & Mosquitoes: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also, treat surfaces around light fixtures on porches, in garages, and other places where these insects alight or congregate. Repeat as necessary.

Ants, Brown Dog Ticks, Crickets, Fleas & Earwigs: For treatment of localized infestation of these insects in outdoor areas where there are weeds or brushy non-crop areas, spray infested areas thoroughly. If removal of brush is desired, use a brush killer first in non-crop areas according to the instructions given on that label. For ants, thoroughly wet hills and runways. Repeat applications as infestations warrant and as reinfestations occur.
