Subject: Amendment - Change to "Caution" Formula Acme Diazinon 25% Emulsifiable Concentrate EPA Reg. No. 33955-556 Your submission dated July 22, 1992

The amendment referred to above, submitted in connection with a registration under the Federal Insecticide, Fungicide, and Rodenticide Act is acceptable provided the following revisions are made prior to release for shipment under the amended labeling:

- 1) Revise the footnote under the ingredients statement to read:
 - ** Contains aromatic petroleum distillates
- 2) Revise the middle of the seventh sentence of the Environmental Hazards text to read "or if waterfowl, i.e., ducks or geese, can be expected in the treated area after treatment (except spot treatment), apply a minimum of 1/4 inch of water".
- 3) In the Precautions under the heading "Lawn Pest Control", revise the middle of the sixth sentence to read "or if waterfowl, i.e., ducks or geese, can be expected in the treated area after treatment (except spot treatment), apply a minimum of 1/4 inch of water".
- 4) For the crop Cabbage, at the end of the Timing/Special Directions for control of Aphids, etc., add a note about resistant leafminers as follows: "Note: Resistant leafminers will not be controlled by diazinon or similar type insecticides.".

Acme Diazinon 25% Emulsifiable Concentrate must be diluted with water before application. Refer to the section "How to Mix and Apply." This product kills many outdoor insects which damage lawns, roses, flowers, trees, shrubs, vegetables, fruits and nuts, and insects which annoy pets and people. Contains diazinon insecticide which provides positive control of many "hard-to-kill" sucking and chewing insects. Acme Diazinon 25% Emulsifiable Concentrate works fast and applications should be regulated only as directed to maintain control.

Notes: (1) USE CONTENTS WITHIN 6 MONTHS AFTER OPENING. SEE "STORAGE AND DISPOSAL" DIRECTIONS. (2) Do not use in the home.
