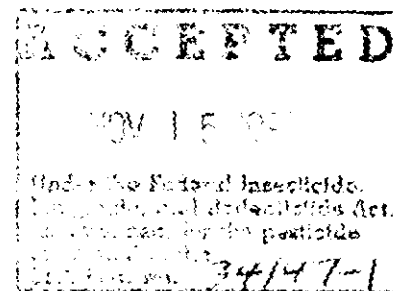

STATEMENT OF PRACTICAL TREATMENT
