"Only For Formulation Into An Insecticide For; (1) The Following Uses: In and Around Non-food Areas Of Residential, Industrial And Institutional Structures And Their Immediate Surroundings And Various Modes Of Transportation; (2) Uses For Which USEPA Has Accepted The Required Data And /Or Citations Of Data That The Formulators Has Submitted In Support Of Registration; And (3) Uses for Experimental Purposes That Are In Compliance With USEPA Requirements."

d. Revise the precautionary statement sub-heading to read as follow:

PRECAUTIONARY STATEMENT HAZARDS TO HUMANS AND DOMESTIC ANIMALS WARNING

- e. Deltamethrin is a type II pyrethroid. Dermal contact (especially to the face) may result in a tingling sensation and reddening of the skin (typical pyrethroid reaction). Therefore the labeling precautionary statements must be revised to include a statement, informing the user that this may occur and washing the skin should result in reversal of the reaction.
