- e. To submit a new 96-hour-Acute Toxicity Flowthrough Conditions using the Eastern Oyster study. (See Ecological Effects Branch review for more information).
- f. Submit and/or cite all data required for registration/ reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.
 - g. Make the following label changes:
 - 1. Revise the EPA Registration Number to read, "EPA Reg. No. 34147-10."
 - 2. Add the following statement describing "Pyrethroid Syndrome" to Hazards to Humans and Domestic Animals: "Skin exposure may result in a sensation described as a tingling, itching, burning, or prickly feeling. Onset may occur immediately to 4 hours after exposure and may last 2 to 30 hours, without damage. Wash exposed areas once with soap and water. Relief from the skin sensation may be obtained by applying an oil-based cream."
 - 3. Under Personal Protective Equipment for handlers exposed to the dilute . . .add the following: "Chemical-resistant apron when mixing or loading, or cleaning equipment."
 - 4. Under Personal Protective Equipment move "Discard clothing and other absorbent materials . . ." to User Safety Recommendations.
 - 5. Revise the Statement of Practical Treatment as follows:

IF IN EYES: Call physician. Hold eye lids open and flush with a gentle steady stream of water for 15 minutes.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention.

IF SWALLOWED: Call physician or poison control center. Drink promptly a large quantity of milk, egg white or gelatin mixture, or if these are not available, a large quantity of water. Avoid alcohol. Do not give anything by mouth or induce vomiting to an unconscious person.

The IF INHALED statement and NOTE TO PHYSICIAN should appear directly following the above statements.

DIRECTIONS FOR USE SUPPLEMENTAL SPRAY RECOMMENDATIONS AND PRECAUTIONS FOR COTTON

- Do not make more than a total of 10 synthetic pyrethroid applications (of one product or combination of products) to a cotton crop in one growing season. Synthetic pyrethroid products include AMBUSH[®], AMMO[®] 2.5 EC, ASANA[®] XL, BAYTHROID 2, CAPTURE[®] 2EC, CYMBUSH, DANITOL 2.4 EC, FURYTM 1.5 EC, KARATE[®], MUSTANG, POUNCE[®] 3.2EC and SCOUT X-TRATM.
- All aerial and ground application equipment must be properly maintained and calibrated using appropriate carriers.

- Spray should be released at the lowest height consistent with good pest control and flight safety. Applications more than 10 feet above the crop canopy should be avoided.
- Make aerial or ground applications when the wind velocity favors on-target product deposition (approximately 3 to 10 mph). Do not apply when wind velocity exceeds 15 mph. Avoid applications when wind gusts approach 15 mph.
- Risk of exposure to aquatic areas can be reduced by avoiding applications when wind direction is toward the aquatic area.
- Do not cultivate within 10 feet of the aquatic area so as to allow growth of vegetative filter strip.
