On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registration exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(B) since you have agreed in your letter dated February 20, 1996 to:

- a. The same terms and conditions for data generation as stipulated in our November 15, 1993 letter for use of tralomethrin on cotton.
- b. The terms and conditions stipulated by the Agency for conditional registration of cotton pyrethroid products, i.e., that the registration and tolerances will automatically expire on November 15, 1996 and November 15, 1997 respectively.
- c. To follow risk mitigation policies as determined by the Spray Drift Task Force Data and Industries Cotton Pyrethroid Working Group (PWG). Current synthetic pyrethroid mitigation measure are interim and may be reconsidered or modified.
- d. To submit production information (pounds or gallons produced) for this product for the fiscal year in which the use on cotton is conditionally registered in accordance with FIFRA Section 29. The fiscal year begins October 1 and ends September 30.

- a. Submit and/or cite all data required for registration/reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.
 - b. Make the following label changes:
 - 1. Revise the EPA Registration Number to read, "EPA Reg. No. 34147-12".
 - 2. Add the following statement describing "Pyrethroid Syndrome" to Hazards to Humans and Domestic Animals: "Skin exposure may result in a sensation described as a tingling, itching, burning, or prickly feeling. Onset may occur immediately to 4 hours after exposure and may last 2 to 30 hours, without damage. Wash exposed areas once with soap and water. Relief from the skin sensation may be obtained by applying an oil-based cream."
 - 3. Under Personal Protective Equipment for handlers exposed to the dilute . . .add the following: "Chemical-resistant apron when mixing or loading, or cleaning equipment."
 - 4. Under Personal Protective Equipment move "Discard clothing and other absorbent materials . . . " to User Safety Recommendations.
 - 5. In the If Swallowed statement revise "Do not induce vomiting" as follows: "Do not induce vomiting because of aspiration hazard."
 - 6. Revise the statemert to read "This pesticide is extremely toxic to fish....
 - 7. Due to acute oral toxicity the pesticide as formulated exceeds the criteria for Restricted Use. Thus modify the second statement in the Restricted Use block to read, "Due to Acute Toxicity, Toxicity to Fish and Aquatic Organisms."
 - 8. The Statement of Practical Treatment must appear on the <u>front panel</u> of the label.
 - 9. Revise the Precautionary Statements as follows: "Fatal if swallowed. Corrosive. Causes irreversible eye damage and skin burns. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Do not get in eyes, on skin, or on clothing. Wear face shield or goggles. Wear protective clothing and rubber

qloves. Harmful if concernings through the skin or inhaled.

Finally, once the required data have been submitted and evaluated, EPA will entertain an application to amend the registration of the subject product to allow the unconditional use on cotton without any special restrictions on the duration of the registration.

RESISTANCE

Some insects are known to develop resistance to products used repeatedly for control. If resistance to this product develops in your area, this product, or other products with a similar mode of action, may not provide adequate control. TANK MIX RECOMMENDATIONS

DECIS 1.5 EC Insecticide may be applied in tank mixtures with other products approved for use on cotton. Observe all restrictions and precautions which appear on the labels of those products.

SUPPLEMENTAL SPRAY RECOMMENDATIONS AND PRECAUTIONS FOR COTTON

- Do not make more than a total of 10 synthetic pyrethroid applications (of one product or combination of products) to a cotton crop in one growing season. Synthetic pyrethroid products include AMBUSH®, AMMO® 2.5 EC, ASANA® XL, BAYTHROID 2, CAPTURE® 2EC, CYMBUSH, DANITOL 2.4 EC, FURY™ 1.5 EC, KARATE®, MUSTANG, POUNCE® 3.2 EC, SCOUT X-TRA®, and SynerGin™2.
- All aerial and ground application equipment must be properly maintained and calibrated using appropriate carriers.

OBSERVE THE FOLLOWING PRECAUTIONS WHEN SPRAYING IN THE VICINITY OF AQUATIC AREAS SUCH AS LAKES; RESERVOIRS; RIVERS; PERMANENT STREAMS, MARSHES OR NATURAL PONDS; ESTUARIES AND COMMERCIAL FISH FARM PONDS.

- Do not apply by ground within 25 feet or by air within 150 feet of lakes; reservoirs; rivers; permanent streams, marshes, or natural ponds; estuaries and commercial fish farm ponds.
- For aerial applications, the spray boom should be mounted on the aircraft so as to minimize drift caused by wing tip vortices. The minimum practical boom length should be used, and must not exceed 75% of wing span or rotor diameter.
- Use the largest droplet Lize consistent with pest control. Formation of very small droplets may be minimized by appropriate nozzle selection, by orienting nozzles away from the air stream as much as possible, and by avoiding excessive spray boom pressure.
- Spray should be released at the lowest height consistent with good pest control and flight safety. Applications more than 10 feet above the crop canopy should be avoided.
- Make aerial or ground applications when the wind velocity favors on-target product deposition (approximately 3 to 10 mph). Do not apply when wind velocity exceeds 15 mph. Avoid applications when wind gusts approach 15 mph.
- Risk of exposure to aquatic areas can be reduced by avoiding applications when wind direction is toward the aquatic area.
- Do not cultivate within 10 feet of the aquatic area so as to allow growth of vegetative filter strip.
