


DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Open attractant carton, remove aluminum strip and bend into "U" shape along scored lines (see Illustration A).

Remove sealed attractant container from carton and peel off adhesive tab covering evaporation hole. Place attractant container inside the "U" of the aluminum strip with evaportion hole facing up. Slide the aluminum "U" into the bulb retainer so that the ends of the aluminum strip protrude through the slots of the bulb retainer (see Illustration B).

The ends of the aluminum strip should be on either side of the bulb. It is not necessary that they contact the bulb itself. When your insect killer is operating, the heat from the bulb will cause the proper amount of attractant to be released from the attractant container.





STORAGE & DISPOSAL: Storage: Store unopened attractant container in a cool, dry place or refrigerate until ready to use. Disposal: Do not reuse attractant container. Wrap attractant container in several layers of newspaper and discard in trash.

PRECAUTIONARY STATEMENTS: Caution: Harmful if swallowed, Keep out of reach of children. Avoid skin and eye contact. Wash thoroughly after handling. Avoid inhaling.

STATEMENT OF PRACTICAL TREATMENT: IF INJESTED — dilute with water and immediately induce vomiting. Do not give fluids or induce vomiting if the victim is unconsistus. Get immediate medical attention. IF INFALED — move to fresh air. Aid in breathing, if necessary, and get immediate medical attention. IF ON SKIN — remove contaminated clothing and wash affected areas with soap and water. IF IN EYES — flush with plenty of water. Call a physician if irritation develops.
