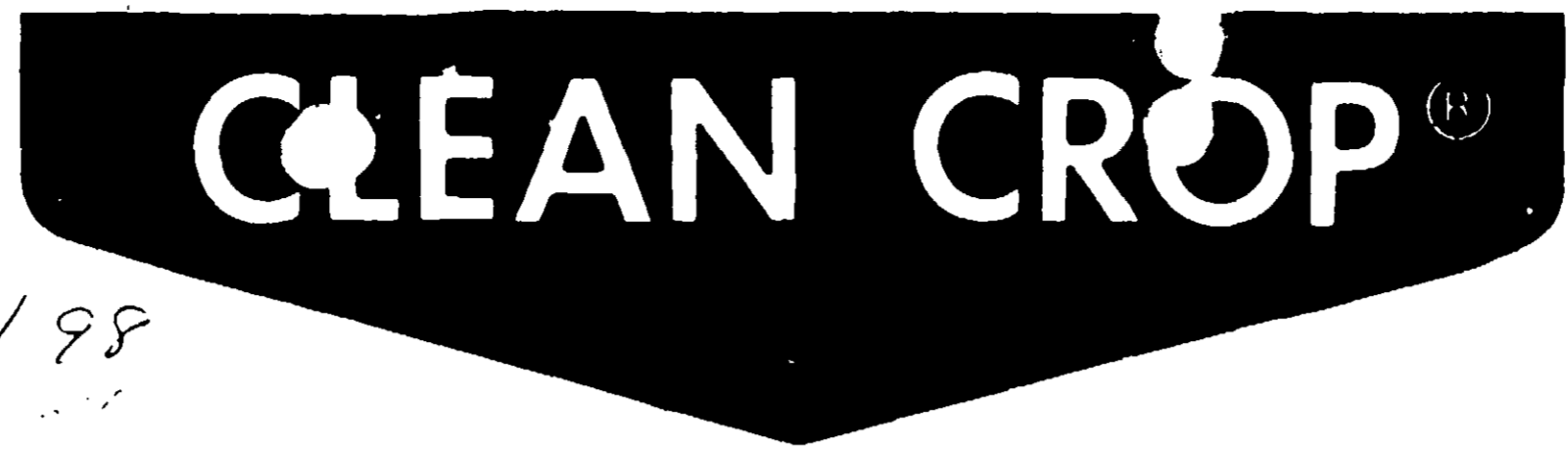

POTATO SEED PIECE TREATMENT — to control Scab and Seed Piece Decay (*Fusarium sambucinum*): Use 1 pound of this product per 100 pounds of whole or cutseed pieces. Apply for thorough coverage. Plant as soon after treatment as possible.
