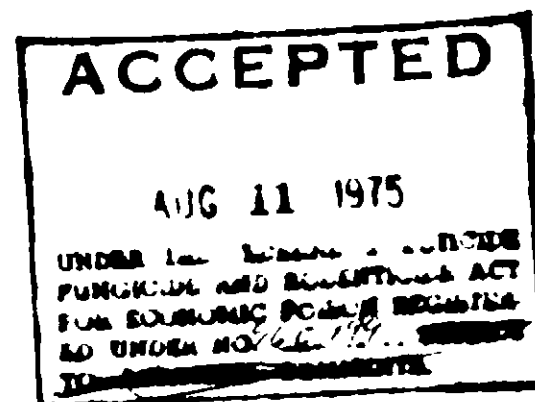

DIRECTIONS FOR USE

POTATO SEED PIECE TREATMENT To control Brown Eye, Damping Off, Seed Rot, Verticillium Wilt: Use 1 to 2 pounds of this product per bushel of seed. Dust seed pieces before planting but pieces should be treated within 6 hours of cutting. If planting is delayed more than 1 or 2 days, treated pieces should be stored 2 days in open crates before bagging.

DO NOT USE TREATED SEED FOR FEED OR FOOD.
