DIRECTIONS FOR USE—(Planter or drill box)

Place 1/2 of the seed in planter or drill box and sprinkle 1/2 the total amount of CLEAN CROP over the seed, mix with paddle or stick until color is imparted to the seed. Add remaining 1/2 of seed and CLEAN CROP and stir as outlined above.

SUGGESTED USE RATE—

Soybeans—Use 2 ounces per bushel (10 ounce can treats 5 bushels of soybean seed.)

Alfalfa, Clover

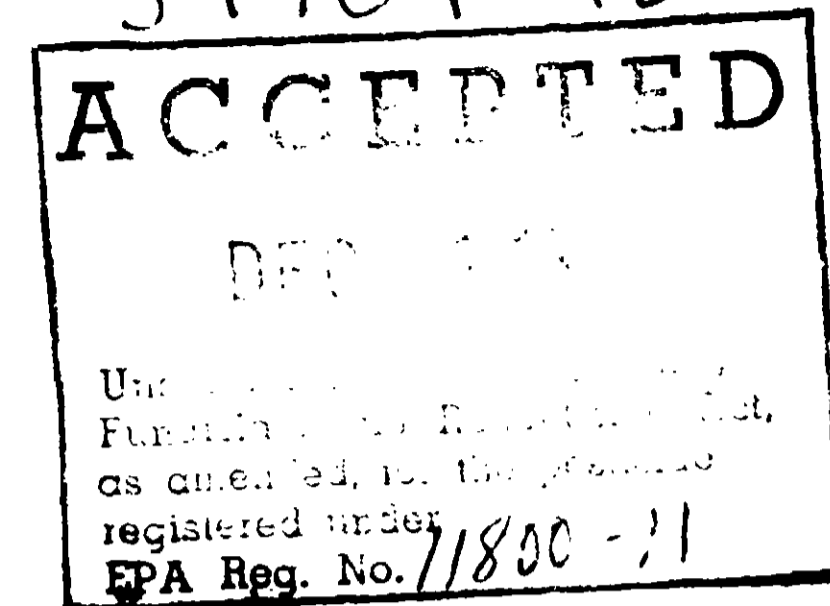
