

Keep children and pets off treated areas until this material is washed into the soil and grass is dry. DO NOT apply to dichondra turf.

STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food, or feed by storage or disposal. Do not store under conditions which might adversely affect the container or its ability function properly. Such conditions include, but are not limited to, positioning of the container in storage, storage temperature, potential for crushing or damage due to stacking, and penetration of moisture.

STORAGE: Store in safe manner. Store in original container only. Store in cool, dry place. Reduce stacking height where local conditions, such as humidity or pallet overhang, can affect package strength.

Immediately after application sprinkle the turf with 1300 gallons of water per acre so as to wash the granules into the zone of insect infestation. Consult the following table to determine amounts of this product and water needed for smaller sized areas. Retreat as necessary.

Controls Ants, Brown Dog Ticks, Chinch Bugs, Crickets, Cutworms, Earwigs, Fleas, Grasshoppers, Sod Webworms (Lawr. Moths), Sowbugs (Pillbugs) infesting golf course turf, road medians and industrial plant sites.
