This amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(7)(a), is acceptable, provided that you:

- Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
- Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - Environmental Hazards, revise terrestrial...high water mark" to read "Do not apply directly to water.".
 - b. Under DIRECTIONS FOR USE change "Federal Law" to "Federal law".
 - c. For the Band Treatment Around House Foundation, revise the treated area from "100 sq. ft. (5' by 20')" to "100 sq. ft. (2' by 50')", since the band width is supposed to be 2 feet wide.
