

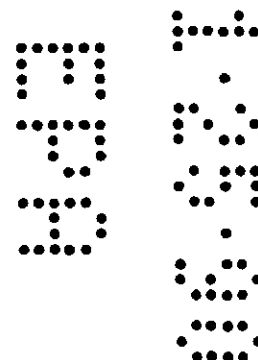

STATEMENT OF PRACTICAL TREATMENT

If swallowed - Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Never induce vomiting or give anything by mouth to an unconscious person.
If Inhaled - Remove victim to fresh air. Apply artificial respiration if indicated.
If On Skin - Remove contaminated clothing. Wash affected areas with plenty of soap and water.
If In Eyes - Flush eyes with plenty of water. Get medical attention if irritation persists.
Note to Physician: This material is a cholinesterase inhibitor. Treat symptomatically. Atropine is an antidote.

RECOMMENDATIONS FOR USE

BACK RUBBING DEVICES OR OILERS: To reduce lice and may also reduce hornflies. Put MALATHION-READY-TO-USE CATTLE OILER COMPOUND into oiler without any dilution. Should be made continuously accessible. Use one rubbing device to each 35-45 head of cattle. Retreat the oiler every 2-3 weeks.
For use on cattle (Beef and non-milking) only. Do not spray or make accessible (back rubbing devices) to lactating dairy animals, or non-lactating dairy animals within 2 weeks of freshening. Do not treat animals under one month of age. May be applied on day of slaughter.
