 - a. Under the subheading entitled "HAZARDS TO HUMANS & DOMESTIC ANIMALS," please revise the statement to read as the following:

"Harmful if swallowed, absorbed through skin, or inhaled. Causes moderate eye irritation. Wash throughly with soap and water after handling. Remove contaminated clothing and wash before reuse."

b. Under the heading entitled "STATEMENT OF PRACTICAL TREATMENT," please revise the ocular statement to read as the following:

"IF IN EYES: Flush eyes with plenty of water. Call a physician if irritation persists."

- c. Under the subheading entitled "Personal Protection Equipment" and in the box entitled "AGRICULTURAL USE REQUIREMENTS," please delete the statement "waterproof gloves." The statement must be superseded by the phrase "a chemical resistant category (A) gloves such as natural rubber, butyl, nitrile, or neoprene rubber."
- d. In the box entitled "AGRICULTURAL USE REQUIREMENTS," please delete the duplicated sentence: "Do not enter or allow worker entry into treated areas during the restricted entry interval (REI) of 12 hours."

NOTE: Local conditions, crop varieties and application regulations vary and may affect use of this herbicide Consolitocal agricultural experiment station or extension service weed speciallists and state regulatory agencies for recommendations in your area.

Aerial application may be of see for control of weeds on certain crops where there would be no danger of drift to susceptible crops. Applications should only be made by applicators experienced in the use of 2.4-D tormulations. Regulations boverning aerial application of herbicides are in effect in many states. Consult local regulation ry agencies concerning requirements before making applications.

Do not apply this product through any type of imgation system.

Treating Small Areas: One tablespoonful of LOW VOL 6 in 1½ gallons of water is about equal to 1 quart in 100 gallons.

TO PREPARE THE SPRAY: (1) Fill the spray tank about half full with water, then add the required amount of LOW VOL 6, with agitation, and finally the rest of the water. NOTE: LOW VOL 6 in water forms an emulsion which tends to separate unless the mixture is kept agitated. (2) If oil is added, first mix the LOW VOL 6 and the oil and then add this mixture to the water. However, with adequate agtation, the oil can be added after the LOW VOL 6 is mixed in the water. (3) If straight oil is used, a solution is formed and separation does not occur. Do nor allow any water to get into the oil-herbicide mixture to avoid formation of an invert emulsion.

TIME OF APPLICATION: Best results are obtained when LOW VOL 6 is used on young weeds that are actively growing. Applications of lower recommended rates to susceptible annual weeds usually will be satisfactory, but for perennal weeds and other conditions, such as in very dry areas where kill is difficult, use higher recommended rates. When used as a selective spray on crops, the stage of growth of the crop must be considered. Some woody plants and weeds are hard to kill and repeat applications may be necessary.

SMALL GRAINS

Spring Wheat and Bartey: Apply % to % pint per acre. Spray when grain is in full tiller stage (usually 4 to 8 inches tail) but before the boot stage and when weeds are small. Do not apply before the filler stage nor from early boot to the dough stage. Higher rates, up to 1% pints per acre, may be needed to handle difficult weed problems in certain areas such as under dry conditions especially in western areas. However, do not use unless possible crop injury will be acceptable.

Winter Wheat and Rye: Apply % to ½ pint per acre in the spring at the full tiller stage but before the early boot stage. For improved control of difficult weeds including wild garlic, wild onion, tarweed and gromwell: apply % to 1% pints per acre. Since these rates may injure the crop, do not use unless possible crop injury will be acceptable. For the high rates on spring wheat and barley as well as winter wheat and rye consult State Agricultural Experiment Station or Extension Service Weed Specialists for recommendations or suggestions to fit local conditions.

Spring Seeded Oats: Apply % pint per acre at the full tiller stage but before the early boot stage. Oats are less tolerant to 2,4-D than wheat or barrey and are more likely to suffer some injury.

- Fail Seeded Oats (Southern) Grown for Grain: Apply ½ to 1 pint per acre after full tillening but before the early boot stage. Some difficult weeds may require higher rates for maximum control but crop injury may result. Do not spray during or immediately following cold weather.
- NOTE: Do not permit dairy animals or meat animals being finished for saughter to forage or graze treated grain fields within 2 weeks after treatment.

Preharvest Treatment: Apply % to 1% pints per acre when grains are in the hard dough stage to control large weeds that may interfere with harvest. Best results will be obtained when soil moisture is sufficient to cause succulent weed growth. NOTE: Do not feed treated straw to livestock.

CORN: Preemergence- Use LOW VOL 6 in sufficient water for uniform coverage. Best results are obtained when applied 3 to 5 days after planting, but before corn emerges. Do not apply to light, sandy soils.

Postemergence- Apply LOW VOL 6 from emergence to tasseling. When spraying com above 10 inches in height, use nozzle extensions ("corn drops"), drecting the soray at base of the corn plant to keep the spray off the leaves as much as possible. Do not apply from tassel emergence to dough stage. Crop injury is more like in to occur if corn is growing rapidly under high temperature and high solt moistur, conditions. Under such conditions, use the lowest recommended rates. Delay cultivation for 8 to 10 days after application to reduce stalk breakage resulting from temporary brittleness caused by 2,4-D. Hybrids vary in tolerance to 2,4-D. Consult local agricultural experiment station or extension service weed specialist regarding the use of 2,4-D on your specific hybrid. Whether or not soybean injury occurs and the extent of the injury will depend on weather and agronomic factors such as the amount of weed vegetation and previous crop residue present that may be in effect between the time of applications and the emergence of the soybean plant.

GRASS SEED CROPS: Use % to 1 pint per acre in the amount of water required for uniform application by air or ground equipment. Apply to established stands in spring from the tiller to early boot stage. Do not spray in boot stage. New spring seedings may be treated with the lower rate after the grasses have at least live leaves. Perennial weed regrowth may be treated in the fail.

Wild Garilc and Wild Onion: Apply 2% pints per acre, making three applications ((fall-spring-fall or spring-fall-spring) starting in late fall or early spring.

Weed Control in Newly Sprigged Coastal Bermudagrass: Apply 1% to 2% pints per acre preemergence and/or postemergence.

Sand Shinnery Oak and Sand Sagebrush: On the oak, use 1% pints in 5 gallons of oil or in 4 gallons of water plus 1 gallon of oil per acre. Apply by aircraft between May 15 and June 15. On the sagebrush, use 1% pints in 3 gallons of oil per acre and apply by aircraft when foliage is fully expanded and the brush is actively growing. 影

Big Sagebrush and Rabbitbrush: Use 2% pints per acre in 2 to 3 gallons of oil or in 3 to 5 gallons of oil-water emulsion spray. Brush should be leafed out and growing actively when treated. Retreatment may be needed

Chamise, Manzanita, Buckbrush, Coastal Sage, Coyote brush and Certain Other Chaparral Species: Use 2% pints per acre in 5 to 10 gallons of water. One gallon of fuel oil may be included in the spray mixture for added effectiveness. Make applications by aircraft or ground equipment to obtain uniform spray coverage. For effective control, the brush must be fuely leafed out and growing actively when sprayed. Retreatment may be needed.

Woody Plant Control: To control 2,4-D susceptible woody plants such as alder, buckbrush, elderberry, sumac and willow on non-crop land, use 1% to 2 guarts LOW VOL 6 in 100 gattons of water. Wet thoroughly all parts of the plants, including foliage and stems, to the point of run-off. Higher volumes are necessary where the brush is very dense and over 6 to 8 feet high. Applications are more effective when applied to actively growing plants. Do not treat during periods of severe drought or in early fall when leaves have lost their healthy green color. Hard-to-kill species may need retreatment the following season.

NON-CROP AREAS SUCH AS ORNAMENTAL TURF, GOLF COURSES, CEME-TERIES, PARKS, ROADSIDES, VACANT LOTS: Apply 1% to 2% pints of LOW VOL 6 per acre in the amount of water needed for uniform application. Treat when weeds are young and growing well. Do not use on creeoing grasses such as bent and St. Augustine except for spot treating, nor on newly seeded turf until grass is well established. Reseeding of treated areas should be delayed following treatment. With spring application, reseed in the fall: with falt application, reseed in the spring. Legumes are usually damaged or killed so do not treat areas where the legumes are desired. Deep-rooted perennial weeds may require repeated treatments in the same season or in subsequent years. For turd, the maximum number of broadcast applications per treatment site is 2 per year

TULE (BULRUSH) AND OTHER RUSHES: Mix 2³/₂ pints of LOW VOL 6 and 1 gallon of diesel oil or kerosene, then add this mixture to 100 galions of water. Spray to wet all foliage (400-800 galions per acre). Addition of a wetting agent may be advisable. Apply in the spring during flower head emergence. Respray if needed when regrowth is 3 to 5 feet tail.

FOREST CONIFER RELEASE: After northern conters tack pine, red pine, back spruce, and white spruce cease growth and "harden off" in late summer, a spray of 1 to 2 quarts of LOW VOL 6 in 8 to 25 gallons of water per acre may be applied by air to control certain competing hardwood speces such as alder, aspen, brch, hazel and willow. Since this treatment may cause occasional conifer injury, do not use if such injury cannot be tolerated. Consult your regional or extension forester or state herbicide specialist for recommendations to fit local conditions.
