WARNING

STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited. Do not reuse empty container. Do not store under conditions which might adversely affect the container or its ability to function properly. Such conditions include, but are not limited to, positioning of the container in storage, storage-temperature potential for crushing or damage due to stacking, and penetration of moisture.


STORAGE: Store in safe manner. Store in original container only. Store in cool dry place. Keep container tightly closed when not in use. Avoid stacking height where local conditions such as humidity, temperature, vermin, can affect package strength. Person health and use of clothing and equipment listed under PRECAUTIONARY STATEMENT when handling open containers.

It contains an effective binding agent to help hold the Lindane on the seed during bulk storing, handling, and planting. It is designed for use in a slurry treater.

ONLY SEED OF HIGH GERMINATION with good vigor should be treated with Lindane. Poor seed may suffer greater injury. It is suggested that seed be treated not over six weeks before planting. What effect prolonged storage has on germination has not been definitely established. Treated seed should be stored in a dry place until planted so that excess moisture may evaporate. If seed is stacked on when wet heat may develop which impairs germination.

IF SOIL TEMPERATURE IS EXTREMELY HIGH due to hot weather, midsummer planting, or other reasons, reduce recommended dosage by one-half. Where seed decay occurs due to soil organisms combine with a protective fungicide.
