WARNING

STORAGE AND DISPOSAL

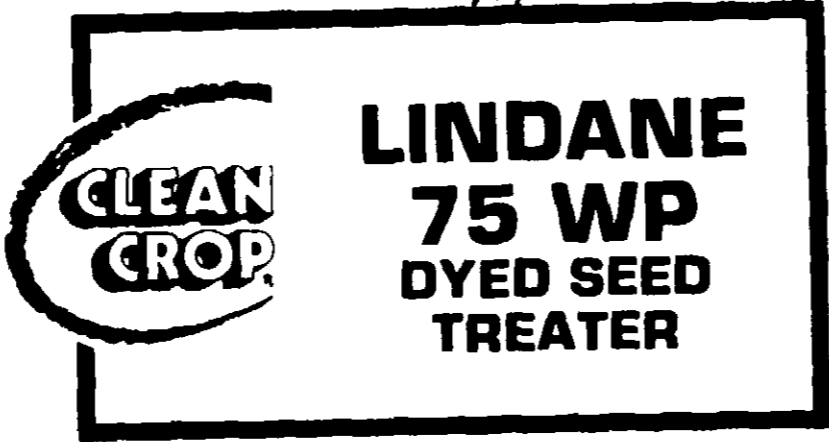

PRODUCT INFORMATION

LINDANE 75 WP is a microfine wettable powder agricultural insecticide designed especially for the treatment of seeds against wireworms, seed corn maggot, and certain other soil-borne insects. It contains an effective binding agent to help hold the Lindane in the seeds during sowing, storing, and planting. It is designed for wet application through slurry treaters.

SEED TREATMENT DOSAGE RATES

Only seed of high germination with good vigor should be treated. Lindane poor seed may suffer greater injury. It is suggested that seed be treated not over six weeks before planting. What effect of storage has on germination has not been definitely established. Seed should be stored in a dry place until planted so that moisture may evaporate. Seed is stained when wet heat mat which impairs germination.

If soil temperature is extremely high due to the weather at planting, or other factors, to reduce the immediate injury caused by Lindane, seed decay may be due to soil-borne fungi. Lindane is a protective fungicide.
