WATERCRESS (Hawaii Only)	Cyclamen Mites	Apply 1 pint per 100 gals. of water per acre.	Apply as a thorough cover spray. Spray should be directed into the crowns and growing tips of plants. If infestation is heavy, make a second application within 10 days after the first application.
