### LIVESTOCK USES

HORSES, CATTLE, GOATS, HOGS, AND SHEEP—Lice: Dilute 1 to 1000 with water. Apply as a thorough coating spray or by dipping to wet all parts of body. Usually 1½ to 3 gallons is required for horses or cuitle and 2 to 4 qts. for sheep, goats, and hogs. Repeat as needed. Sheep Ticks: Dilute 1 to 49 with water. Apply as a spray or by dipping to wet all portions of body. Repeat as needed.

**POULTRY HOUSES**—Chicken Mites and Bedbugs: For chicken mites dilute 1 to 19 with water. Apply liberally and thoroughly as a driving spray with particular attention to perch poles, nests and cracks in floors and walls. Spray litter thoroughly. Repeat treatment when needed. For Bedbug cor ibl dilute 1 to 9 parts of water.


**CATTLE AND HORSE**—Horse Flies, Stable Flies, and Deer Flies: Dilute 1 to 9 with water. Apply as a spray at the rate of about 1 qt. per animal to wet over entire body. Spray each animal completely with particular attention to the legs and underline. Spray applications on animals to be protected should be made routinely every 3 days.

CATTLE AND HORSES—Horn Flies and Mosquitoes: Dilute 1 to 19 with water. Apply as a spray at the rate of about 1 qt. per animal to wet hair over entire body. Spray each animal completely with particular attention to the legs and underline. Spray applications on cattle to be protected should be made on a once a week schedule.
