DIRECTIONS FOR USE

Apply dust to give thorough coverage of all plant surfaces. May be applied with airplane or ground application equipment at the rate of 20 to 40 pounds per acre depending on the size of the plants. Apply at 7 to 10 day intervals to protect new growth throughout the growing season. More frequent applications may be required under severe disease conditions.

POTATOES: Early Blight, Late Blight - Start applications when the plants are about 6 inches high.

TOMATOES: Early Blight, Late Blight, Septoria Leaf Spot, Bacterial Spot - Start applications when the first fruits are set or in areas where blights are normally severe begin applications when the plants are set in the field. Use 50 pounds per acre for late blight on maturing plants.

CELERY: Early Blight, Late Blight, Septoria Leaf Spot - Start applications when the plants are set in the field.

CUCUMBERS, MELONS, PUMPKIN, SQUASH: Angular Leaf Spot, Downy Mildew, Anthracnose - Apply at 5 to 7 day intervals throughout the growing seasons.

CARROTS: Leaf Blight.

EGGPLANT, PEPPERS: Late Blight.

LIMA BEANS: Downy Mildew, Pod Spot.

LETTUCE: Downy Mildew.

SUGAR BEETS: Leaf Spot.

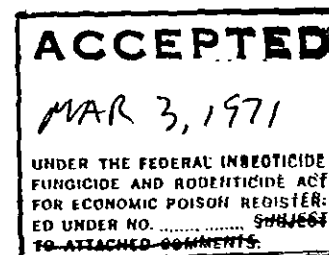

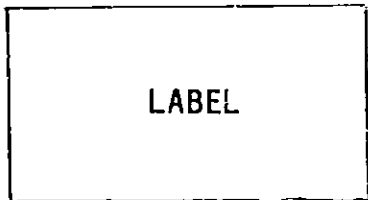
