WHAT THIS ACCEPTANCE MEANS:



MIXING DIRECTIONS: Before using this product, be some the spray tank is clean and contains just enough water to cover the agitator shaft. With agitator running, start filling tank with water; add oil when tank is about half full. Pump this mixture through the overflow and back into the tank for about two minutes to insure proper emulsification. Fill with water, adding other desired materials as tank is filling. Keep agitator running at all times. Sufficient agitation must be present to insure proper emulsification. If an injector is used, first add 25 to 50 gallons of water to tank with engine running to provide good pressure. Put injector suction tube into the measured amount of spray oil, opening injector valve to allow the oil to be sucked into the tank, then fill the tank with water.

Do not use this material if it does not emulsify.

Use efficient equipment of the proper type, Avoid apraying during or immediately prior to hot or freezing weather (over 90°F or under 32°F), hot dry winds, rain or other unautable conditions; avoid overspraying or double spraying. Plants should be sprayed only when in vigorous condition and when their moisture condition is suitable.

Do not make an oil spray application within 2 weeks prior to, or after an application of sulfur. On Citrus do not make an oil application within 60 days prior to, or after an application of sulfur.

Apply when pests first appear. Apply the following recommended rates in sufficient water to thoroughly cover one acre. By ground use a minimum of 200 gallons of diluted spray per acre. Do not use in undiluted form.

On not apply this product through any type of irrigation system. GRAPEFRUIT, LEMONS, ORANGES:

Yellow Scale, Citricola Scale, Red Scale, Brown Soft Scale, Citrus Red Mite—Use 11/2 to 2 gallons per 100 gallons of water.

OLIVES: Olive Scale, Black Scale, Oleander Scale—Use 11/z to 2 gallors per 100 gallons of water.
