Spray horses with a mist spray only. Avoid wetting the hides of animals. Harmful if swallowed or absorbed through the skin. Do not get in eyes, on skin or on clothing. Wash thoroughly after handling and before eating or smoking. Do not breathe spray mist.

**HORSES:** Flies (Horn, House and Stable), Mosquitoes: Spray application only: Apply 2 fl. ozs. daily per adult horse and 1 oz. daily for younger animals. For best results apply in the morning for protection during the day. Do not overdose. Apply as a fine mist only. Proper coverage results in moistened hair without wetting hide. Keep spray away from animals eyes and nostrils. Horses occasionally exhibit dermal sensitivity. Discontinue use of this product if symptoms such as inflammation or scaliness appear. Do not apply to open wounds, proud flesh or harness areas.  
**STABLES & KENNELS:** Flies, Gnats, and Mosquitoes. Do not contaminate water or feed. Repeat as necessary. This spray can be used in thermal foggers and mist sprayers.
