Subject: Label Amendments in Response to Basic Suppliers Deletion of Certain DDVP uses. Selco Vapona 0.5% Insecticide Reg. No. 34704-604 Your Submission Dated May 16, 1995

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, amended, is acceptable subject to the comments listed below. Two copies of the finished labeling must be submitted prior to releasing the product for shipment.

- Under "Precaution Using" add: "Do not treat more than 5 application sites per day and do not make DDVP applications more than once per week."
- 2. Delete the "If swallowed" sentence under the precautionary statement since it already appears under statement of practical treatment.
- 3. Under "Precautionary statements" add "Wear chemical resistant gloves (such as nitrite or butyl)long-sleeved shirt, long legged pants, shoes and socks when handling the product."
- 4. Add the following statement the first sentence under Note to Physician:

"This product contains DDVP (dichlorvos) which is an organophosphate chemical and cholinesterase inhibitor."

5. Revise the Environmental Hazards statement as follows:

"This product is toxic to fish and wildlife. Do not apply directly to water or to areas were surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwaters."

6. Revise the current statement Precaution in Using to read: Wear a respirator with either an organic vapor removing cartridge with a prefilter approved for pesticides (MSHA/NIOSH approval number prefix TC-23C), or a canister approved for pesticides (MSHA/NIOSH approval number prefix TC-14G); when applying as a fog or fine mist in foggyng equipment.

7. Add the following precautions to outdoor area directions: Do not apply this product within 100 feet (30 meters) of lakes, rivers, streams. Do not allow spray treatment directly onto water supplies. For best results treat when insects are most advise and weather conditions are conducive to keep the fog (mist) close to the ground e.g. cool temperatures and wind speed not greater than 10 mph. Applications during the cool hours of the night or early morning is usually preferable.

Files, Mosquitoes, Gnats, Flying Moths and Wasps: Apply as a coarse wet spray or apply with a paint brush to areas on outside of house around cracks, walls and particularly around cracks of doors and window frames. For the protection and provention of these insects entering into human dwellings make application as a spot treatment. Thorough and repeated application, should be made to screens, window frames, door sills on porches and patios where these insects alight or congregate. For the Control of wasps spray the nest after dark when all insects have feurned to the nest.
