The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Two copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped label is enclosed for your records.

- Identify the purpose of the product on the front panel beneath the "Not for Sale for any Other Uses", i.e., "For use in cattle feed lots, stockyards, holding pens, corrals and agricultural premises.
- 2. The ingredient statement should declare the active ingredients as: Dichlorvos {2,2-dichlorovinyl dimethyl phosphate \.
- Delete the current personal protective clothing statements and replace with the following:

Wear coveralls worn over long-sleeved shirt and long pants, socks, chemical resistant footwear, chemical resistant gloves and protective eyewear. Wear a respirator with either an organic vapor removing cartridge with a prefilter approved for pesticides (MSHA/NIOSH approval number prefix TC-23C), or a canister approved for pesticides (MSHA/NIOSH approval number prefix TC-14G); and a chemical resistant apron when mixing or loading. Keep all unprotected persons out of operational area.

4. Revise the Environmental Hazards statement to read as follows:

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS DANGER

This product is poisonous if swallowed, inhaled, or absorbed through the skin or eyes. Do not get on skin or eyes. Do not breathe fumes. Avoid prolonged exposure to fumes. Wear clean rubber gloves, protective clothing and goggles when handling the concentrate to prepare solutions. Wear a mask or respirator of a type passed by the U.S. Department of Agriculture for DDVP (Vapona insecticide) protection. Keep all unprotected persons out of operational area.

In case of contact, wash immediately with soap and water. Wash thoroughly with soap and water before eating or smoking. Wash all contaminated clothing with soap and hot water before reuse.

STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger, or, if available, by administering syrup of ipecac. Do not induce vomiting or give anything by mouth to an unconscious person.

IF ON SKIN: If the material has been spilled on the skin, immediately remove patient from the vicinity of the insecticide, remove all contaminated clothing, and wash skin with soap and running water.

IF IN EYES: Wash immediately with running water for at least 10 minutes Get medical attention immediately.

IF INHALED: Remove victim to fresh air immediately. Apply artificial respiration if indicated. Get medical attention.

ATROPINE is the emergency antidote for VAPONA® insecticide poisoning. 2-PAM is also antidotal and may be administered in conjunction with atropine. Consult your physician about obtaining an adequate supply of 1-100-grain atropine tablets, or 2-PAM for emergency use. CALL A PHYSICIAN IMMEDIATELY IN ALL CASES OF SUSPECTED POISONING.

NOTE TO PHYSICIANS

WARNING SYMPTOMS: Symptoms include weakness, headache, tightness in chest, blurred vision, non-reactive pin-point pupils, salivation, sweating, nausea, vomitting, diantiea and abdominal cramps.

TREATMENT: Atropine is the specific therapeutic antagonist of choice against parasympathetic nervous stimulation. If there are signs of parasympathetic stimulation, atropine sulfate should be injected at 10 minute intervals, in doses of 1 to 2 milligrams, until complete atropinization has occurred.

Morphine is contraindicated. Clear chest by postural drainage. Observe patient continuously for 48 hours. Repeated exposure to cholinesterase inhibitors may without warning cause prolonged susceptibility to very small doses of any cholinesterase inhibitor. Allow no further exposure until time for cholinesterase regeneration has been allowed as determined by blood test.

ENVIRONMENTAL HAZARDS

For terrestrial uses, do not apply directly to water, or to creas where surface water is present or to intertidal areas below the mean high water mark. Highly toxic to fish and wildlife. Do not contaminate water by cleaning of equipment or disposal of wastes.

PRECAUTIONS IN USING

This product and the diluted emulsion are poisonous. Therefore, precautions must be observed with handling them. (See antidote and warnings on this label). Store the concentrated solution in a safe place. Children and animals must not be able to reach or handle the concentrate or diluted solution. It is recommended that only the amount of diluted solution that will be used immediately be prepared from the concentrate.

Mix the concentrate into diesel oil or No. 2 fuel oil outdoors or in a well ventilated room. Wash off the outside of the container of concentrate in running water before storing away. Do not contaminate any body of water nor apply to any area not specified on label.

Do not contaminate feed, water or foodstuff, milk or milking utensils.

IMPORTANT: Not for use or storage in or around the home.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. Do not reuse empty container. Do not store under conditions which might adversely affect the container or its ability to function properly.

STORAGE: Do not store below temperature of 0°F. Store in a safe manner. Store in original container only. Store in cool, dry place. Keep container tightly closed when not in use. Reduce stacking height where local conditions can affect package strength. Personnel should use clothing and equipment listed under DANGER when handling open containers.

SPILLED MATERIAL: Block or dike to prevent spreading of spill. Cover with absorbent materials such as lime, clay or sawdust. Scoop and sweep into a disposal container. Wash area with strong lye solutions, absorb and place into a disposal container.

To prepare a 0.5% spray dilute 1 pint of this product with 15 gallons of diesel oil. Apply with a mist blower or other suitable equipment as an over-all application at the rate of 0.2 lbs. of technical VAPONA per acre (approximately 5 gallons of 0.5% spray). Particular attention should be given to areas where files congregate such as fences, spillage areas, around feed bunks and walls of buildings. Animals may be present during treatment. Avoid direct application to exposed feed and water.

AGRICULTURAL PREMISES: Animal Shelters, Barns, Dairy Barns, Feed Lots, Milk Sheds, Pig Pariors, Poultry Houses, Stables and other Farm Buildings.

Apply this product as 1.0% fog to control flies and gnats. To prepare a 1.0% fogging solution, dilute 1 pint to 7.5 gallons of diesei cil. Apply as a fog or mist inside building at the rate of 1 pint per 8,000 cu. ft. Do not contaminate feed, drinking water, milk or milking equipment. Do not apply in areas where animals have received direct application within 8 hours.
