The degree of control is dependent upon species, stage of growth and overall growing conditions. Best results are obtained when weeds are young and actively growing.

To prepare the spray solution: add about half of the water to the mixing tank, then add this herbicide with agitation and finally the balance of the water with continuing agitation. Use only water. SELECTIVE WEED CONTROL IN CROPS

CORN (Field and Sweet) AND SORHGUM (Milo): Apply 1/2 to 1 pound of this behilder of this herbicide per acre when corn and sorghum are at least 4 to 10 inches tall. Drop nozzles are recommended after the cropyeaches 8 to 10 inches in height to keep spray off foliage. Do not apply to point from tasseling to dough stage.
