

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application.

Following application, workers (e.g. baggers) must wear chemical resistant gloves while potatoes are wet.

Do not enter or allow any person, other than a person equipped with the appropriate handler personal protective equipment including the appropriate respirator, to enter the treated area until the area has been ventilated. 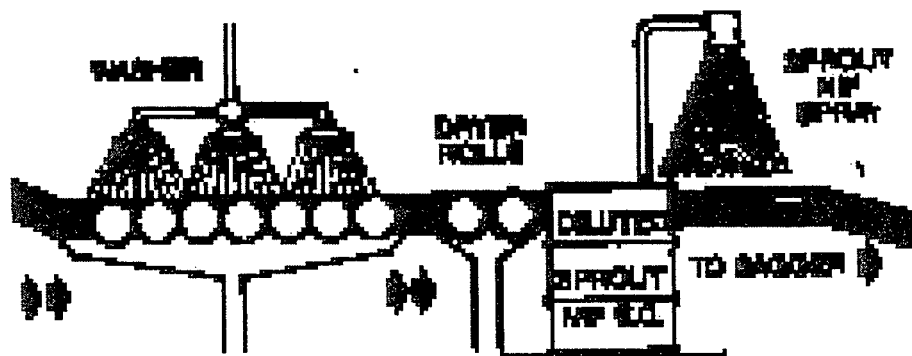
Spray nozzle should be set to spray evenly across rolls moving the potatoes.

Dryer rolls will distribute SPROUT NIP Emulsifiable Concentrate to assure complete coverage of each potato.

**APPLICATION**

Dilute SPROUT NIP Emulsifiable Concentrate to a 1% emulsion by adding 1 gallon of SPROUT NIP Emulsifiable Concentrate to 35 gallons of water. Agitate enough to form a uniform emulsion.
