DANGER

IF IN EYES: Flush with plenty of water. Call a physician.

IF SWALLOWED: Call Physician or Poison Control Center Immediately. Drink promptly a large quantity of milk, egg whites, gelatin solutions, or if these are not available, drink large quantities of water. Avoid alcohol. Do not induce vomiting or give anything by mouth to an unconscious person.

Only seed of high germination with good vigor should be treated with this product. Poor seed may suffer greater injury. Treat only those seeds needed for immediate use, minimizing the interval between treatment and planting. Store treated seed in a dry place until planted so that excess moisture will evaporate. If seed is stacked when wet, heat may develop which could impair germination.
