The following specific comments pertain to your WPS labeling submission concerning the product cited above:

The respirator requirement for "applicators and other handlers" in the "Personal Protective Equipment" section on your proposed labeling is missing or incorrect. Remove the incorrect requirement (if any) and add "Dust/mist filtering respirator (MSHA/NIOSH approval number prefix TC-21C)." The exact location is shown in Sections A and B on Part I of the Product Worksheet in Supplement Three-A to PR Notice 93-7.

Add the following statement to the "Personal Protective Equipment" section on your labeling: "When handlers use closed systems, enclosed cabs, or aircraft in a manner that meets the requirements listed in the Worker Protection Standard (WPS) for agricultural pesticides [40 CFR 170.240(d)(4-6)], the handler PPE requirements may be reduced or modified as specified in the WPS." Exception: If "closed systems," "enclosed cabs," and "aircraft" cannot all be used with your product, you may omit from the statement any that are not applicable. The exact location is shown in Section A on Part 1 of the Product Worksheet in Supplement Three-A to PR Notice 93-7.

Delete the following statements from the "Personal Protective Equipment" section on your proposed labeling: "The closed systems or enclosed cabs must be used in a manner that meets the requirements listed in the Worker Protection Standard (WPS) for agricultural pesticides [40CFR 170.240(d)(4-6)]. 

PRODUCT INFORMATION

LINDANE 25 PLANTER BOX SEED TREATER is a dust base agricultural insecticide especially firmulated for seed treatment at planting time. This product is formulated to help lubricate the planter box and assure smooth even seed flow to the furrow.

LINDANE 25 PLANTER BOX SEED TREATER is formulated for use in the treatment of seeds for protection against wireworms, seed corn maggots, and certain other solborne insects. Where seedling B'ight, Damping-Off, or seed decay normally occurs, combine this product with a full dosage of protective fungicide, such as CAPTAN 25 PLANTER BOX SEED TREATER.

SEED TREATMENT: Do not use treated seed for food, feed, or oil purposes. Treated seed should be labeled in accord with all the applicable requirements of the Federal Seed Act. The Federal Seed Act requires that seed treated with a pesticide must contain a dye which imparts an unnatural color to the seed if the seed is intended to be moved in interstate commerce. Labels attached to treated seed must state "Treated seed must not be used for food, feed or oil purposes" and, "Exposed treated seed may be hazardous to birds and other wildlife. Dispose of excess treated seed by burial away from bodies of water."

Only seed of high germination with good vigor should be treated with lindane. Poor seed may suffer greater injury. Treat seed not over 6 weeks before planting. Store treated seed in a dry place until planted so that excess moisture will evaporate. If seed is stacked when wet, heat may develop which could impair germination.

Store all treated seed in a cool dry place.

FOR IMPROVED MIXING OF PRODUCT WITH SEED: For ORY TREAT-MENT, mix product with the seed in any commercial or barrel treater, until thoroughly coated. For PLANTER BOX method, fill the box only half full of seed and half the required amount of product and mix thoroughly with a stick. Then add the remainder of the seed to the box and add the rest of the required amount of product to the seed, again mixing thoroughly.
