When used as directed, it provides protection against seed borne and soil borne fundi which cause damping-off and seedling blights. This product aids in control of Achlya in rice seed, Puccinia carthami Cda which causes foot-and-root disease and foliage rust disease in safflower, as well as stinking smut (bunt) of wheat, covered smuts of barley, and seed decay.

IMPORTANT: Before using, stir thoroughly to mix contents.

Read all directions and use only as specified on this label. Thoroughly mix the recommended amount of this product into the required amount of water for the slurry treater equipment and dilution rate to be used.
