Treated moss turns black quickly, indicating that the moss is dying. Large areas of dead moss should be raked away and overseeded with a high quality lawn seed.

HOW TO APPLY:


1. Mow the lawn to expose as much moss as possible. If possible, catch or rake and remove clippings.

2. Apply uniformly at the recommended use rate using a quality lawn spreader. Contents of 50.0 pound bag covers 6250 square feet (1.0 pound covers 125 square feet).

3. Apply when sidewalks are dry. Sweep sidewalks and masonry free of this product prior to lawn watering. This product contains iron sulfate which may stain concrete and masonry.

4. Water thoroughly following application.

AMOUNT TO APPLY: For established lawns, apply at the rate of 40 lbs. to cover 5,000 sq. ft.





SUGGESTED SPREADER SETTINGS: The following spreader settings are for use with new equipment at average walking speed and level terrain. A used spreader may need calibration. Many factors, such as incorrect settings, walking speed, terrain, wear, spreader calibration and general condition of the spreader can affect the rate of application. Since these conditions are beyond our control, neither the formulator nor the retail merchant can guarantee exact coverage as indicated by the recommended spreader settings. **If you have reason to believe that your spreader is not calibrated correctly,** test apply by placing the amount needed to cover 500 sq. ft. into your spreader and apply to a pre-measured 500 sq. ft. area.
