

GENERAL INFORMATION: This product is recommended for selective postemergent weed control in lawns and ornamental turf, and non-crop areas as listed. Apply when temperatures are warm (70° F+) and weeds are actively growing. Control is more effective at 80 to 90° F.

WEEDS CONTROLLED: **Grassy Weeds:** Crabgrass, Dallisgrass, Sandbur, Goosegrass, Nutgrass (Nutsedge), Foxtail, Barnyard Grass, Bahiagrass, and Johnsongrass. **Broadleaf Weeds:** Cocklebur, Puncturevine, Chickweed, Wood Sorrel, and Pigweed.

MIXING: Fill the spray tank ½ full and then thoroughly dissolve this product into the spray solution; then fill tank to proper level. Clean application equipment thoroughly after use by flushing with water in a safe place.

HOW TO APPLY: Use a hand pump sprayer, a garden type pressure sprayer, or sprinkler can. Do not use a sprayer that is used for the application of insecticides or fungicides due to possible contamination. Thoroughly wet all target weeds. Avoid wetting desirable turf grass where possible. Do not apply this product with a hose-end applicator. A fan type nozzle will give best results. Apply on a calm day to avoid spray drift to susceptible plants.

ORNAMENTAL TURF GRASS

Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production, or for research purposes.

Apply as a postemergent spray to control weeds listed hereon. Do not use on new lawns until after the second cutting. Desirable turf grass may be temporarily discolored without lasting effects. Zoysiagrass, Bluegrass, and Bermudagrass are quite tolerant. Do not use on St. Augustine Grass, Carpetgrass, Centipede Grass, or Dichondra lawns. Bent grass and fescues may be damaged. Mow the turf to a height of 1½ inches before treatment.

Mixing Rate: Add 6 fluid ounces of this product to 3 gallons water to treat 1000 sq. ft. (This is equal to 2 gallons of this product per acre.) Thoroughly wet all weeds. Two or more repeat applications at 14-day intervals may be necessary.

This spray is particularly effective for control of Crabgrass, Foxtail, and Chickweed in the lawn. If possible, treat weeds when in the seedling stage and before they go to seed. Best results will be obtained if the soil is moist. Small areas may be watered before application to increase the spray effectiveness. However, DO NOT water turf for at least 24 hours after application. DO NOT reseed until 2 weeks after last application.

NON-CROP AREAS

For use on plants in non-crop and non-timber areas only. Not for use on crops, timber, or other plants being grown for sale or other commercial use, or for commercial seed production, or for research purposes.

This product is useful in the maintenance of drainage ditches, rights-of-way (including highway, railroad, pipeline and utility), fence rows, storage yards and many similar areas to control weeds as listed hereon.
