The amendment referred to above, submitted in connection with registration under section (3) of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA) is acceptable provided that you make the following changes:

Ingredient Statement:

Line up the percentages of active ingredient, inert ingredient and "total" so that the decimal points fall along the same vertical line.

Signal Word:

Since this product was claimed to be a me-too with Clean Crop Potato Seed Treater PS, EPA Registration Number 34704-730, you must change the signal word from Caution to Warning and add the Spanish/English statement: "Si usted no entiende la etiqueta, busque a alguien para que se la explique a usted en detalle. (If you do not understand the label, find someone to explain it to you in detail.)"

Precautionary Statements:

- Add the sentences "Wear protective eyewear (goggles, face shield, or safety glasses).
 Remove contaminated clothing and wash clothing before reuse."
- Add "and protective eyewear (goggles, face shield, or safety glasses)" to the end of the statement beginning "Applicators and other handlers must wear . . ."
- Add the subheading "Physical and Chemical Hazards" immediately below the "Environmental Hazard" section and move the sentence "Keep away from fire and sparks." from its current place immediately preceding the "Personal Protective Equipment" heading so that it follows the "Physical and Chemical Hazards" subheading.

Directions for Use:

Immediately following "Do not use treated seed for feed or food purposes" replace the heading "Caution" with "Note" or "Important" or some other word which is not one of the designated toxicity signal words "Caution", "Warning" or "Danger".

Storage and Disposal:

- Move the "Storage and Disposal" section to the end of the Directions for Use.
- Delete the word "Prohibitions".
- Move the text beginning "Do not store under conditions . . ." and ending " . . . and penetration of moisture." to the end of the Storage section.
- Change the heading "Storage" to "Pesticide Storage".
