STATEMENT OF PRACTICAL TREATMENT

If swallowed: Call a physician or poison control center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching the back of the throat with finger. Repeat until vomit fluid is clear. Do not induce vomiting or give anything by mouth to a person who is unconscious or convulsing.

If inhaled: Remove victim to fresh air. Apply respiration if indicated.

If on skin: Remove contaminated clothing and wash affected areas with soap and water.

If in eyes: Flush eyes with plenty of water. Call a physician immediately.

Note to Physician: Endosulfan is a central nervous system stimulant absorbable by clothing, inhalation, or through contact with skin. It may cause convulsions. There is no specific antidote. Diazepam I.V. is the drug of choice. Barbituric acid derivatives such as Phenobarbital may be used additionally. A neuromusular blocking agent may be used if convulsions persist. This type of drug may be used only if complete control of respiration can be maintained. Epinephrine derivatives are absolutely contraindicated.
