The labeling amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, As Amended (FIFRA), is acceptable, provided that you submit five copies of your draft label incorporating the following corrections for our approval.

1. Correct the maximum amount of active ingredient applied per acre from 4.4 lbs. to 1.5 lbs. as is specified in the acephate Interim Reregistration Eligibility Decision (IRED) Use Pattern Table, Appendix A.


2. Add the minimum spray intervals cited below as are specified in the IRED, section IV.D., Labeling Summary Table.

3 days for rates up to 0.5 lb. a.i./A
7 days for rates greater than 0.5 lb. a.i./A.

If this condition is not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product bearing the amended label constitutes acceptance of this condition.
