- The correct registration number for Def 6 (Tribbufos) is 264-730. Submit a Formulator's Exemption Statement (Form 8570-27) with correct registration number.

Make the following label changes listed below before you release the product for shipment:

- 5. Under "Personal Protective Equipment";
  - Add "such as chemical goggles, or face shield" after "protective eyewear."
  - Replace "For exposure in enclosed areas, a respirator . . . prefilter" with the following:
    - "For exposure in enclosed areas, a NIOSH approved half-mask or a full facepiece respirator equipped with a combination of organic vapor/HE or P-100 particulate filter cartridges with NIOSH approval number prefix TC-23C, or a NIOSH approved gas mask equipped with a combination of organic vapor/FIE or P-100 particulate filter canister with NIOSH approval number prefix TC-14G."
  - Replace the last statement with "For exposure outdoors, a NIOSH approved respirator equipped with R, P, or HE-series particulate filters with NIOSH approval number prefix TC-84A."

It is recommended that you require that applicators and handlers be trained in the fitting, inspection, use, and maintenance of personal protective equipment.

6. Under "Engineering Controls Statements";

Add the following statements:

- Mixers and loaders supporting aerial applications must use a mechanical transfer system that meets the requirements listed in the Worker Protection Standard (WPS) for agricultural pesticides [40 CFR 170.240(d)(4)] for providing dermal protection. The system must be capable of removing the pesticide from the shipping container and transferring it into mixing tanks and/or application equipment. At any disconnect point, the system must be equipped with a dry disconnect or dry couple shut-off device that is warranted by the manufacturer to minimize drippage to not more than 2 ml. per disconnect point. In addition to wearing the specified PPE, all handlers of this product must wear chemical resistant gloves and a chemical resistant apron.
- Persons using a closed system that operates under pressure shall wear protective eyewear.
- Pilots must use an enclosed cockpit that meets the requirements listed in the Worker Protection Standard (WPS) for agricultural pesticides [40 CFR 170.240(d)(6)].
- 7. Under "User Safety Recommendations";

Add the following statements:

"Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing."

8. Under "First Aid - If swallowed";

Replace "Have a person sip a glass of water if able to swallow" with "Do not give any liquid to person."

9. Under "Note to Physician";

Add "This product is corrosive to eyes or skin."

- Add "Cotton treated with this product must be mechanically harvested. Hand harvesting is prohibited."

# 12. Under "Ground Application";

Add the following spray drift management statements:

- Do not allow sprays to drift from the application site and contact people, structures people occupy at any time and nontarget crops, aquatic and wetland areas, woodlands, pastures, rangelands, or animals.
- For ground rig applications, apply product no more than 4 feet above the ground or the crop canopy and only when wind speed is 10 mph or less at the application site as measured by an anemometer.

# 13. Under "Aerial Application";

Add the following spray drift management statements:

Avoiding spray drift at the application site is the responsibility of the applicator. The interactions of many equipment-and-weather-related factors determine the potential for spray drift. The applicator and the grower are responsible for considering all these factors when making decisions.

The following drift management requirements must be followed to avoid off-target drift movement from aerial applications to agricultural field crops. These requirements do not apply to forestry applications, public health uses or to applications using dry formulations.

- The distance of the outer most nozzles on the boom must not exceed 3/4 the length of the wingspan or rotor.
- Nozzles must always point backward parallel with the air stream and never be
  pointed downwards more than 45 degrees.
   Where states have more stringent regulations, they should be observed. The
  applicator should be familiar with and take into account the information covered
  in the Aerial Drift Reduction Advisory Information.

The following aerial spray drift management requirement are advisory in nature and does not supersede mandatory label requirements:

# **INFORMATION ON DROPLET SIZE**

The most effective way to reduce drift potential is to apply large droplets. The best drift management strategy is to apply the largest droplets that provide sufficient coverage and control. Applying larger droplets reduces drift potential, but will not prevent drift if applications are made improperly, or under unfavorable environmental conditions (see Wind, Temperature and Humidity, and Temperature Inversions).

# **CONTROLLING DROPLET SIZE**

- Volume Use high flow rate nozzles to apply the highest practical spray volume. Nozzles with higher rated flows produce larger droplets.
- Pressure Do not exceed the nozzle manufacturer's recommended pressures.
   For many nozzle types lower pressure produces larger droplets. When higher flow rates are needed, use higher flow rate nozzles instead of increasing pressure.
- Number of nozzles Use the minimum number of nozzles that provide uniform coverage.
- Nozzle Orientation Orienting nozzles so that the spray is released parallel to
  the airstream produces larger droplets than other orientations and is the
  recommended practice. Significant deflection from horizontal will reduce
  droplet size and increase drift potential.

Nozzle Type - Use a nozzle type that is designed for the intended application. With most nozzle types, narrower spray angles produce larger droplets. Consider using low-drift nozzles. Solid stream nozzles oriented straight back produce the largest droplets and the lowest drift.

#### BOOM LENGTH

For some use patterns, reducing the effective boom length to less than 3/4 of the wingspan or rotor length may further reduce drift without reducing swath width.

# APPLICATION HEIGHT

Applications should not be made at a height greater than 10 feet above the top of the largest plants unless a greater height is required for aircraft safety. Making applications at the lowest height that is safe reduces exposure of droplets to evaporation and wind.

# **SWATH ADJUSTMENT**

When applications are made with a crosswind, the swath will be displaced downwind. Therefore, on the up and downwind edges of the field, the applicator must compensate for this displacement by adjusting the path of the aircraft upwind. Swath adjustment distance should increase, with increasing drift potential (higher wind, smaller drops, etc.)

#### WIND

Drift potential is lowest between wind speeds of 2-10 mph. However, many factors, including droplet size and equipment type determine drift potential at any given speed. Application should be avoided below 2 mph due to variable wind direction and high inversion potential. NOTE: Local terrain can influence wind patterns. Every applicator should be familiar with local wind patterns and how they affect spray drift.

# TEMPERATURE AND HUMIDITY

When making applications in low relative humidity, set up equipment to produce larger droplets to compensate for evaporation. Droplet evaporation is most severe when conditions are both hot and dry.

# TEMPERATURE INVERSIONS

Applications should not occur during a temperature inversion because drift potential is high. Temperature inversions restrict vertical air mixing, which causes small suspended droplets to remain in a concentrated cloud. This cloud can move in unpredictable directions due to the light variable winds common during inversions. Temperature inversions are characterized by increasing temperatures with altitudes and are common on nights with limited cloud cover and light to no wind. They begin to form as the sun sets and often continue into the morning. Their presence can be indicated by ground fog; however, if fog is not present, inversions can also be identified by the movement of smoke from a ground source or an aircraft smoke generator. Smoke that layers and moves laterally in a concentrated cloud (under low wind conditions) indicates an inversion, while smoke that moves upward and rapidly dissipates indicates good vertical air mixing.

#### SENSITIVE AREAS

The pesticide should only be applied when the potential for drift to adjacent sensitive areas (e.g. residential areas, bodies of water, known habitat for threatened

DEF 6 is a cotton defoliant, which may be used for the removal of leaves from cotton plants prior to the antidipated hervest of the crop. DEF 6 contains six (6) pounds of active ingredient per gallon, it is non-corresive and non-clogging to spray equipment and does

DEF 6 must be applied in sufficient amounts of spray carrier to provide thorough coverage of leaves. DEF 6 treated leaves do not appear affected until defoliation actually begins and the leaves drop in a green condition. Under lavorable conditions, defoliation of cotton normally occurs within four to seven days following application. Adverse conditions such as low temperature (especially temperatures below 60° F at night), low humidity or plant stress may extend the defoliation time to nine to fourteen days. Under these adverse (conditions, use the Higher recommended DEF 6 rate and/or use dieset of rather than water as the spray carrier.

Meavy rainfall during or immediately following a DEF 6 application may result in reduced performance. Application is not recommended when a heavy rainfall is expected within one hour after treatment. Dow on the plant leaves at time of application should not affect

#### MIXING INSTRUCTIONS

Compatibility of DEF 6 or its labeled tank mix products should always be productermined prior to mixing. Refer to the COMPATIBILITY SECTION of this label for further details.

DEF 6 Alone: Fill the spray tank ½ to ¾ full of clean water, initiate the recirculation and agitation system and add the recommended amount of DEF 8. Continue sufficient agitation from the time of mixing through application to onsure a uniform spray mixture. Follow the same mixing instructions when diesel oil is substituted for water.

DEF 6 Tank Mixtures: Fill the soray tank 15 to 15 full of clean water and begin the sprayer recirculation and agitation system, if tank mixing with wellable powders of other dry prod-ucts, make a sturry of these products with water and add sturry slowly to the spray lank. Next add the recommended amount of DEI 6. If mixing spray adjuvants in the mixture, add them after all other products have been mixed. Fill the spray tank to the desired level with water and continue agitation during transport and application until the spray tank is empty. Follow the same mixing instructions when deset oil is substituted for water.

Ground Application: Use spray equipment that provides a uniform and accurate application. A minimum spray volume of 10 gallons per acro is recommended when DEF 6 is applied with water and a minimum of 5 gallons per acre is recommended when DEF 6 is applied in diasel oil.

Aerial Application: Use serial equipment calibrated to provide accurate and uniform spray coverage and application rates and to minimize the potential for spray drift. Do not apply when wind may cause drift.

A minimum spray volume of 5 gallions per arze should be used when DEF 6 and tank mixtures with DEF 6 are applied with water. DEF 6 alone may be applied in a minimum of 3 gallons of spray volume per acre when using diesel oil (minimum of 5 gallons per
