c.) Note, the application directions label: "1 1/8 rate per Acre" referring to "Scleroderris canker" (pines) and "1 5/8 rate per Acre" referring to "Siroccoccus tip blight", the rates require dashes, to appear as: "1-1/8" and "1-5/8" to assure the rates as specified are unambiguous.

d.) Under "Conifers" delete "non-bearing".

5. "Chlorothalonil 90DF" should appear throughout the label in place of "Chlorothalonil", this correction will increase the label's legibility by providing uniformity.

6. Label block "Agricultural Use Requirements" requires the following additions to be included for completeness and consistency: "Coveralls over long-sleeved shirts and long pants, chemical-resistant gloves, chemical-resistant footwear plus socks, protective eyewear, chemical-resistant headgear". The last sentence of this block must include: "Notify workers of the application by warning them orally and by posting warning signs at entrances to treated areas." These corrections are consistent with Agency requirements as specified in the Label Review Manual as it pertains to Worker Protection Standards (p. 10-28).

7. #### General Precautions and Restrictions

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

DO NOT apply this product in a way that will contact workers or other persons, or pets, either directly or through drift. Only protected handlers may be in the area during applications. For any requirements specific to your State or Tribe, consult the Agency responsible for pesticide regulation.

### AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses and handlers of agricultural pesticides. Avoiding spray drift at the application site is the responsibility of the applicator. The interaction of many equipment and weather related factors determine the potential for spray drift. The applicator and the grower are responsible for considering all these factors when making decisions. The following drift management requirements must be followed to avoid off-target drift movement from aerial applications to agricultural field crops. 1. The distance of the outer most nozzles on the boom must not exceed 3/4 the length of the wingspan or rotor.

2. Nozzles must always point backward parallel with the air stream and never be pointed downwards more than 45 degrees.

#### **AERIAL DRIFT ADVISORY INFORMATION** INFORMATION ON DROPLET SIZE

The most effective way to reduce drift potential is to apply large droplets. The best drift management strategy is to apply the largest droplets that provide sufficient coverage and control. Applying larger droplets reduces drift potential but will not prevent drift if applications are made improperly, or under unfavorable conditions (see Wind, Temperature). CONTROLLING DROPLET SIZE

- Volume Use high flow rate nozzles to apply the highest practical spray volume.
- Nozzles with higher rated flows produce larger droplets.
- Pressure Do not exceed the nozzle manufacturer's recommended pressures. For many nozzle types lower pressure produces larger droplets. When higher flow rates are needed, user higher flow rate nozzles instead of increasing pressure
- Number of nozzles Use the minimum number of nozzles that provide uniform coverage
- · Nozzle orientation Orienting nozzles so that the spray is released parallel to the airstream produces larger droplets than other orientations and is the recommended practice. Significant deflection from horizontal will reduce droplet size and increase drift notential
- · Nozzle type Use a nozzle type that is designed for the intended application. With nost nozzle types, narrower spray angles produce larger droptets. Consider using low-drift nozzles. Solid stream nozzles oriented straight back produce the largest droplets and the lowest drift potential.

BOOM LENGTH

For some use patterns, reducing the effective boom length to less than 3/4 of the wingspan or rotor length may further reduce drift without reducing swath width. APPLICATION HEIGHT

Applications should not be made at a height greater than 10 feet above the top of the largest plants unless a greater height is required for aircraft safety. Making applications at the lowest height that is safe reduces exposure of droplets to evaporation and wind, SWATH ADJUSTMENT

When applications are made with a crosswind, the swath will be displaced downwind. Therefore, on the up and downwind edges of the field, the applicator must compensate for this displacement by adjusting the path of the aircraft upwind. Swath adjustment distance should increase with increasing drift potential (higher wind, small drops, etc.).

#### WIND

Drift potential is lowest between wind speeds of 2-10 mph. However, many factors, including droplet size and equipment type determine drift poter-tial at any given speed. Application should be avoided below 2 mph due to variable wind direction and high inversion potential. NOTE: Local terrain can influence wind patterns. Every applicator should be familiar with local wind patterns and how they affect spray duth.

TEMPERATURE AND HUMIDITY

When making applications in low relative hemotity, set up equipment to produce larger droplets to compensate for evaporation. Drivolet evaporation is most sovere when conditions are both hot and dry.

TEMPERATURE INVERSION

Applications should not occur during a temperature inversion because drift potential is high. Temperature inversions restrict vertical air mixing, which causes small suspended droptets to remain in a concentrated cloud. This bloud can move in unpredictable directions due to the light variable winds common نامية g inversion. Temperature inversions are characterized by increasing temperatures with altitude and are common on nights with limited cloud cover and light to no wind. They begin to form as the sun sets and often continue into the morning. Their presence can be indicated by ground fog; however, if fog is not present, inversions can also be identified by the moleculation of smoke from a ground source or an aircraft smoke generator. Smoke that lavers and moves laterally in a concentrated cloud (under low wind conditions) indicates an inversion, while smoke that moves upward and rapidly dissipates indicates good vertical air mixing.

## INTEGRATED PEST MANAGEMENT

CHLOROTHALONIL is an excellent disease control agent when used according to the label directions for control of a broad spectrum of plant diseases. CHLOROTHALONIL is recommended for use in programs that are compatible with the principles of Integrated Pest Management (IPM), including the use of disease resistant crop varieties, cultural practices, pest scouting and disease forecasting systems which reduce unnecessary applications of pesticides.

## FUNGICIDE RESISTANCE MANAGEMENT

CHLOROTHALONIL is effective for strategic use in programs that attempt to minimize disease resistance to fungicides. Some other fungicides which are at risk from disease resistance exhibit a single-site mode of fungicidal action. CHLOROTHALONIL, with a multi-site mode of action, may be used to delay or prevent the development of resistance to single-site fungicides. Consult with your federal or state Cooperative Extension Service representatives for guidance on the proper use of CHLOROTHALONIL in programs which seek to minimize the occurrence of disease resistance to other fungicides.

#### MIXING, LOADING AND APPLYING

CHLOROTHALONIL is intended to be diluted into water, then applied to crops by typical agricultural spraving techniques. Always apply CHLOROTHALONIL in sufficient water to obtain thorough, uniform coverage of foliage and crop surfaces intended to be protected from disease. Spray volume to be used will vary with crop and amount of plant growth. Spray volume should normally range from 20 to 150 gallons per acre (200 to 1400 liters per hectare) for dilute sprays and 5 to 10 galions per acre (50 to 100 liters per hectare) for concentrate ground sprays and aircraft applications. Both ground and aircraft methods of application are recommended unless specific directions are given for a crop.

Measure the required amount of CHLOROTHALONIL and pour into the spray tank during filling. Keep agitator running when filling spray tank and during spray operations. Do not use on greenhouse-grown crops except as directed in the Ornamental Plants section of this label.

Apply 4.6 ounces of CHLOROTHALONIL 90DF per 1,000 square teet of turf area (12.6 libs per acre). Application must be made before snow cover in autumn. If snow cover is intermittent or lacking during the writter, re-apply CHLOROTHALONIL at monthly intervals until Gray Snow Mold conditions no longer prevail. In areas where Pink Snow Mold (Microdochium or Fusarium patch) is likely to occur, apply CHLOROTHALONIL 90 DF at 4.6 ounces in combination with products containing iprodione at 2 ounces active ingredient, per 1.000 square feet of turf area. Read and observe all label directions for products containing these active ingredients.

Fusarium (Microdochium) Patch: CHLOROTHALONIL is effective against Fusarium patch only in areas where snow cover is intermittent or lacking during the winter. Apply 4.6 ounces of CHLOROTHALONIL 90 DF per 1.000 square leet of turf area. Begin applications in late autumn and re-apply at 21 to 28 day intervals until conditions favorable for Fusarium patch no longer prevail.

Algai scum: Apply CHLOROTHALONIL 90DF at 1.7 to 3 ounces per 1,000 square feet on a 7 to 14 day schedule. When colonies of algae are well established, every attempt should be made to dry out the afflicted area. Once dry, spiking or verticutting should be done to enhance turfgrass recovery in conjunction with the use of CHLOROTHALONIL. Several applications of CHLOROTHALONIL at the high rate may be necessary for turgrass recovery. When environmental conditions are favorable for algae growth, a preventive program with CHLOROTHALONIL, will suppress re-colonization of the turf.


