Label Changes

The comments below apply to the label submitted to and received by EPA on June 15, 2010.

1. Make sure that the type size used for the child hazard warning (“**KEEP OUT OF REACH OF CHILDREN**”) meets or exceeds regulatory requirements (e.g., at least 12-point type for a front panel ≥ 30 square inches).
2. To avoid confusion with the “**If swallowed:**” text, the last sentence of the “**NOTE TO PHYSICIAN:**” should be deleted.
3. Move the “**PHYSICAL / CHEMICAL HAZARDS**” paragraph (page 2) so that it follows the “**CAUTION**” paragraph and precedes the “**PERSONAL PROTECTIVE EQUIPMENT (PPE)**” text.
4. In the second sentence of the “**CROP-SPECIFIC INFORMATION**” paragraph, replace “recommended” with “specified”.
5. In the “**STORAGE AND DISPOSAL**” box (page 5), change the subheading “**STORAGE:**” to “**PESTICIDE STORAGE:**”.

SPRAY DRIFT MANAGEMENT

A variety of factors including weather conditions (e.g., wind direction, wind speed, temperature, relative humidity) and method of application (e.g., ground, aerial, airblast) can influence pesticide drift. The applicator and grower must evaluate all factors and make appropriate adjustments when applying this product.

WIND SPEED: Do not apply at wind speeds greater than 15 mph at the application site.

TEMPERATURE INVERSIONS: If applying at wind speeds less than 3 mph, the applicator must determine if a) conditions of temperature inversion exist, or b) stable atmospheric conditions exist at or below nozzle height. Do not make applications into areas of temperature inversions or stable atmospheric conditions.

DROPLET SIZE: Apply as a medium or coarser spray (ASABE standard 572), and the minimum volume mean diameter (VMD) for spinning atomizer nozzles.

When applied through ground equipment: Apply using a nozzle height of no more than 4 feet above the ground or crop canopy.

WIND SPEED: Do not apply at wind speeds greater than 15 mph at the application site.

DROPLET SIZE: Apply as a medium or coarser spray (ASABE standard 572), and the minimum volume mean diameter (VMD) for spinning atomizer nozzles.

When applied as a spray through airblast equipment: For airblast applications, turn off outward pointing nozzles at row ends and when spraying outer row. To minimize spray loss over the top in orchard applications, spray must be directed into the canopy.

When applied as an aerial spray:

RELEASE HEIGHT: For aerial applications of agricultural products, do not release spray at a height greater than 10 feet above the ground, top of crops, or above the orchard canopy.

BOOM LENGTH: The boom length must not exceed 75% of the wingspan or 90% of the rotor blade diameter.

SWATH ADJUSTMENT: When applications are made with a cross-wind, the swath will be displaced downwind. The applicator must compensate for this displacement at the downwind edge of the application area by adjusting the path of the aircraft upwind. Leave at least one swath unsprayed at the downwind edge of the treated field.

WIND SPEED: Do not apply at wind speeds greater than 15 mph at the application site.

DROPLET SIZE: Apply as a medium or coarser spray (ASABE standard 572), and the minimum volume mean diameter (VMD) for spinning atomizer nozzles.

PRODUCT USE INFORMATION

FIRST CHOICE® GAVICIDE-C® is a straight-cut, narrow boiling range petroleum oil designed specifically for use on citrus.

RESTRICTIONS

CHEMIGATION: DO NOT APPLY this product through any type of irrigation system.

DILUTION: Fill spray tank with 1/2 the required amount of water. Start agitator. Add total amount of spray oil. Continue to agitate while adding balance of water and while spraying.

Ground applications: Dilute specified dosage in 50-2,000 gallons of water per acre.

Aerial applications: Dilute FIRST CHOICE GAVICIDE-C at the rate of 10-30 gallons per acre in sufficient volume of water for thorough coverage (consult with local Extension Service or agricultural chemical authority for dilution and/or combinations with currently registered pesticides). Use lower rate on susceptible varieties or young trees. In case of conflicting directions, refer to the specific crop instructions.

COMPATIBILITY: FIRST CHOICE GAVICIDE-C may be tank-mixed with insecticides or fungicides. To assure the compatibility of tank mixtures, mix the correct proportions of the tank-mix components in a small container. After thorough mixing, let stand for five minutes. If the combination remains mixed or can be readily remixed, the tank mixture is compatible.

APPLICATIONS: FIRST CHOICE GAVICIDE-C is formulated as a "fast break" spray oil and will not stay in solution unless agitated constantly. Keep agitator running at all times during spray operations. Apply so as to give total coverage to all parts of crop. Thorough drenching of trunks, limbs, twigs and leaves is essential for optimum results.

DO NOT APPLY this product within 30 days before or after an application of sulfur.

DO NOT APPLY to trees weakened by disease, drought, drying winds, or high nitrogen applications.

DO NOT USE FIRST CHOICE GAVICIDE-C when temperatures are above 90°F when making low volume applications or above 95°F when making high volume applications.

CROP-SPECIFIC INFORMATION

Apply as pests appear. Adjust dosage within recommended range according to pest infestation, crop canopy size, crop condition, etc. FIRST CHOICE GAVICIDE-C may be reapplied if pest pressure continues.

NAVEL ORANGES, VALENCIA ORANGES, GRAPEFRUIT, LEMONS, LIMES AND OTHER CITRUS spp.:

To control Citrus Red Mite, Red Scale, Yellow Scale and Black Scale.

For dilute, high-volume cover sprays, apply 1.0 to 1.4 gallons of FIRST CHOICE GAVICIDE-C per 100 gallons of water.

For concentrated, low-volume sprays, apply 10 to 22 gallons of FIRST CHOICE GAVICIDE-C in not less than 50 gallons of total spray per acre.

Do not exceed a maximum of 212 pounds of active ingredient (in a maximum volume of 2000 gallons of spray mix) per acre when treating citrus in California. Do not exceed a maximum of 159 pounds of active ingredient (in a maximum volume of 1500 gallons of spray mix) per acre when treating citrus in Florida or Texas.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store only in original container in locked storage areas. If a spill occurs, visible puddles or drops should be covered with a dry absorbent such as clay, sawdust, lime or soda ash. Sweep up and dispose of in a permitted disposal facility. Avoid cross-contamination with other pesticides and fertilizers during handling and storage. Do not store near heat or open flame. Not for use or storage in or around the home.

Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. **Pressure rinse as follows:** Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow

begins to drip.

For packages greater than 5 gallons and less than 56 gallons: Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. **Pressure rinse as follows:** Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

For packages greater than 56 gallons: To clean the container before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container about 10 percent full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times.

For refillable containers: Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. To clean the container before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container about 10 percent full with water.
