Leave at least one swath unsprayed at the downwind edge of the treated field.

### APPLICATION DIRECTIONS

Gavicide® 470 Spray Oil is a straight-cut, narrow boiling range petroleum oil designed specifically for use as a foliar or dormant/delayed dormant application on fruit and nut crops.

**Dilution:** Dilute specified dosage in 50.0 to 2000 gallons of water per acre as directed below and in 15.0 to 30.0 gallons for aircraft as needed for coverage. Fill spray tank with 1/2 the required amount of water. Start agitator. Add total amount of spray oil. Continue to agitate while adding balance of water.

**Compatibility:** Gavicide 470 Spray Oil may be tank-mixed with insecticides or fungicides. To assure the compatibility of tank mixtures, mix the correct proportions of the tank-mix components in a small container. After thorough mixing, let stand for five minutes. If the combination remains mixed or can be readily remixed, the tank mixture is compatible.

**Chemigation:** DO NOT APPLY this product through any type of irrigation system.

**Applications:** Gavicide 470 Spray Oil is formulated as a "fast break" spray oil and will not stay in solution unless agitated constantly. Keep agitator running at all times during spray operations. Apply so as to give total coverage to all parts of crop. Thorough drenching of trunks, limbs, twigs and leaves is essential for optimum results.

### USE LIMITATIONS

- DO NOT COMBINE with sulfur sprays, or apply spray oil within 30 days before or after an application of sulfur unless allowed by the Directions for Use of this product and the sulfur product.
