

**DIRECTIONS FOR USE
GENERAL CLASSIFICATION**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

CEMCO 965 is used in industrial and/or commercial recirculating cooling tower systems and industrial air-washing systems to control microbiological slime. Prior to the use of CEMCO 965 in industrial and/or commercial recirculating cooling tower systems, systems should be cleaned to remove algal growth, microbiological slime, and other deposits. Then make an initial slug addition of 5.7 to 8.6 fl. oz. of CEMCO 965 per 1000 gal. of water to provide 30 to 45 ppm of CEMCO 965 based on total weight of water in the system. Repeat initial dosage until control is evident. Make subsequent slug addition of 2.9 to 8.6 fl. oz. of CEMCO 965 per 1000 gal. of water (15 to 45 ppm CEMCO 965) every 2 to 5 days or as needed. The frequency of addition depends upon the relative amount of bleed-off and the severity of the microbiological problem. Slug additions should be made in the sump of recirculating cooling tower systems.

CEMCO 965 is used in industrial air-washing systems which maintain effective mist eliminating components. Prior to its use, systems should be cleaned to remove bacterial slime and other deposits. An initial slug dose of 13.5 to 17.2 fl. oz. of CEMCO 965 per 1000 gal. of water is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 10.0 to 17.2 fl. oz. of CEMCO 965 per 1000 gallons of water should be employed every 1 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and severity of the bacterial problem. Slug additions may be made to the sump or the water collection trays of the airwash system. In EPA 1-1-18

Then have patient drink plenty of milk, gelatin solution, beaten egg whites, flour and water, or other nonalloy demulcent. Never induce vomiting or give anything by mouth to an unconscious person.*
