

GENERAL INFORMATION: Hi-Yield (R) Bug Bait is very effective for control of listed insects around the home, in flower and ornamental gardens and greenhouses. It contains attractant to lure snails and slugs to bait.

Direction: The bait should be applied to soil around plants but not directly to stems, trunks, or foliage. Sprinkly bait lightly on ground in areas to be treated, preferably in late evening, because these pests are mostly late evening and night feeders. Also place bait where these pests hide during the day. Do no apply in piles.

Make application in early spring and repeat as necessary to maintain control. For the bests results areas to be treated should be damp. If necessary, water prior to applying.

Snails and slugs migrate extensively! Migration from infested areas may be prevented by baiting a barrier from the adjacent, infested areas.

WARNING: Keep out of reach of children. May be fatal if swallowed. Avoid breathing dust. Avoid contact with skin. Wear regular long-sleeved work clothing. Change to clean clothing daily. Wash hands and face before eating. Wash thoroughly after handling. STATEMENT OF PRACTICAL TREATMENT:

IF SWALLOWED: Call a physician or Poison Control Center immediately. Drink 1 or 2 glas-es of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.

IF INHALED: Remove vitim to fresh air. Apply artificial respiration if indicated.

IF ON SKIN: Remove contaminated clothing and wash affected areas with soap and water.

IF IN EYES: Wash eyes with plenty of water. Call a physician if irritation persists.

Do not store near or contaminate feed or feedstuffs. Kéép children and pets off treated areas.

ENVIRONMENTAL HAZARDS: This product is toxic to birds and wildlife. Birds feeding on treated areas may be killed. Do not apply directly to water or wetlands (swamps, bogs, marshes, and potholes).
