Subject: Revised Labeling per PR Notices 2001-1 and 2001-6; Revised CSF Hi-Yield® Bug Bait EPA Registration No. 34911-8 Your Submission Dated October 18, 2001

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided you make the following changes before you release the product for shipment bearing the amended labeling:

- 1. Revise your Inert Ingredients statement to read 95.0%. Also, the term "Active Ingredient" should be plural.
- 2. Under the First Aid heading revise the statement to "Carbaryl is an Nmethyl....inhibitor." In the First Aid section you are encouraged to add a company telephone number or toll-free hotline number. You may use the National Pesticide Telecommunications Network (NPTN). See the enclosed pamphlet for more information.
- 3. Revise the Note to Physician section as follows: "Carbaryl is an N-methyl carbamate the inhibits cholinesterase. Atropine is antidotal. Do not use 2-PAM (pyridene-2-aldoxime methiodide), opiates or cholinesterase inhibiting drugs. Probable mucosal damage may contraindicate the use of gastric lavage."
- 4. Revise the Precautionary Statements as follows: "May be fatal is swallowed. Harmful if inhaled or absorbed through skin. Avoid contact with skin, eyes or clothing. Avoid breathing dust. Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco. Remove contaminated

clothing and wash clothing before reuse. This pesticide may be fatal to dogs or other pets if eaten. Keep pets out of treated areas."

- 5. Under Directions for Use, the statement "Place bait where these pests hide during daylight hours" is vague and confusing. Are homeowners expected to know where these pests can be found? Either clarify or delete the statement. Also, add "Do not put granules in piles" to this section.
- 6. Under General Information add: "Do not apply to or around food crops."
- 7. Under Directions for Use add: "Always use protective gloves."

The confidential statement of formula for the basic formulation dated October 18, 2001 is acceptable. This CSF has been added to your file and supercedes all pervious versions.

GENERAL INFORMATION: Hi-Yield[®] Bug Bait is very effective for control of listed insects around the home, in flower and ornamental gardens and greenhouses. It contains attractant to lure snails and slugs to bait.

DIRECTIONS: The bait should be applied to soil around plants but not directly to stems, trunks, or foliage. Sprinkle bait lightly on ground in areas to be treated, preferably in late evening, because these pests are mostly late evening and night feeders. Also place bait where these pests hide during the day. Do not apply in piles. Scatter it so the bait can hardly be seen on the ground or grass. The bait is stomach poison and works slowly. Results will be apparent in 1 to 3 days after applying. One pound of bait will treat approximately 500 square feet.

Make application in early spring and repeat as necessary to maintain control. For the best results areas to be treated should be damp. If necessary, water prior to applying.

Snails and slugs migrate extensively! Migration from infested areas may be prevented by baiting a barrier from the adjacent, infected areas.

STORAGE AND DISPOSAL

STORAGE: Keep out of reach of children and pets. Store in original containers only. Store in cool, dry place and avoid excess heat.

DISPOSAL: If empty: Do not reuse this container. Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
