**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**INDOORS-FOR SPOT APPLICATION ONLY**

Use Hi-Yield® Kill-A-Bug® as a spot treatment to control cockroaches, silverfish, spiders and other pests specified below. Apply as a coarse spray to localized areas where pests may occur. Spray surfaces until wet. Retreat as needed. Application of this product in indoor residential settings, other than as a spot and/or crack and crevice treatment is not permitted.

**Cockroaches, Crickets, Silverfish, Spiders:** Spray areas where these pests are found or may hide, especially dark corners of rooms and closets, cracks and crevices in walls; along baseboards and door and window sills and frames, behind and beneath sinks, stoves, refrigerators and cabinets, and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly.

**Ants:** Apply to ant trails, also around doors and windows and wherever these pests may find entrance.

**Brown Dog Ticks:** To control these pests, apply as a spot treatment to infested areas. Use only as a crack and crevice treatment along and behind baseboards, window and door frames and localized areas of floors and floor coverings where pests may be present, and pet resting place. do not use as a space spray. **Do not spray pet, or their bedding.** Do not spray on desirable plants. Remove pets and cover fish bowls before spraying. For use in home and office. Do not use in edible products of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

**Flies and Mosquitoes:** For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the home. Treat dark corners and localized resting areas under eaves on porches, around patios and garages. Repeat as necessary. Also treat surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate.

**STORAGE AND DISPOSAL**

**STORAGE:** Store in original container and place in a locked storage area.

**DISPOSAL:** Do not reuse container. Rinse thoroughly before discarding in trash. Securely wrap container in several layers of newspaper and discard in trash.
