**CONTROLS:** Aster Beetle, Cabbage Looper, Imported Cabbageworm, Rose Chafer, Rose Slug, Flea Beetles, Cucumber Beetles (Diabrotical), Aphids (Green & Rosy) and Adult Japanese Beetle.

At first appearance of pest or its damage, dust lightly, directly from this container thorough the sifter top or apply with a hand duster. Apply to upper and lower leaf surfaces. Repeat at 4 to 7 day intervals or until pests are under control.
