DIRECTIONS FOR USE

- (It is a violation of Federal Law to use this product in a manner inconsistent with its labeling)

For use in Homes, Schools, Warehouses, Office Buildings, Theatres, Garages, Hotels, Kennels.

ATTACH EXTENSION TUBE TO SPRAY VALVE. SHAKE BEFORE USE. HOLD CONTAINER UPRIGHT. APPLY IN SHORT BURSTS.

TO PREVENT OR EXTERMINATE INFESTATION.- Apply spray along baseboards and around the door, drawer and window frames, particularly in the kitchen and bathrooms areas; under sinks, where plumbing enters into the building; all parts of the room suspected of harbouring these pests; cracks and hidden surfaces; behind stoves and refrigerators; food storage areas. To treat Cracks and Crevices insert the tip of the tube and spray directly into them and between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, and furniture legs and bases. Repeat in few days if necessary.

FOR SPOT TREATMENT.- Spray directly, at a distance of about 1 to 2 feet, and contact as many insects as possible. To kill ants, treat door and window frames, trails and other areas of entry.

FOR PET'S FLEAS.- To kill pet's Fleas, Brown Dog Ticks, etc.: Remove and dispose of pet's old bedding. Spray sleeping quarters, around baseboards, window and door frames, wall cracks and local areas of floors. Do not spray animals. Pet's old bedding should be replaced with clean, fresh bedding after treatment. Also treat the pets with a registered flea and tick control product before allowing them to re-enter treated areas.

FOR SPACE SPRAY.- To kill flying insects: Close all doors and windows of the room. Direct the spray upward, above head level, from center of room with a slow rotating motion and straight arm. Spray about 10 seconds per 1,000 cubic feet or average-size room. Leave room and keep it closed for 30 minutes after spraying. Ventilate room thoroughly before re-entry.

STORAGE AND DISPOSAL OF CONTAINER

Storage: In cool area away from heat and open flame.

Disposal: Wrap container and put in trash collection.
