NON-CROP WEED CONTROL - INDUSTRIAL USE ONLY

Weed Blast 4-G is a non-selective herbicide for controlling a wide range of annual and perennial weeds and grasses. It is recommended only for noncropland areas such as railroad, utility and highway rights-of-way and industrial areas. 200 to 400 pound applications of Weed Blast 4-G per acre usually result in a non-productive condition of the soil for a period of a year or more. The duration of non-productivity is dependent upon rainfall, soil type and other conditions.

Weed Blast 4-G should be applied as furnished with a seed spreader, a fertilizer spreader, or with any equipment which will distribute the chemical uniformly over the area to be treated. For the control of annual and most perennial weeds and grasses, apply Weed Blast 4-G at the rate of 200 to 400 pounds per acre; on small plots 1/2 to 1 pound per 100 square feet. Repeat spot treatment may be required when deep-rooted perennial weeds are present. To obtain the best results, Weed Blast 4-G should be applied to the ground where it will be absorbed by the roots. Applications made early in the season have been found to give results superior to applications at a later seasonal date. Weed Blast 4-G may, however, be applied at any time of the year except when the ground is frozen. Maximum effectiveness in arid regions is obtained when application is made just prior to the rainy season. Users should consult

state agricultural experimental stations or extension service weed specialists for recommendations as to use in their particular area.

IMPORTANT: Do not apply on or near desirable woody or herbaceous plants or on areas where their roots may extend because of possible injury to such plants. Thoroughly clean spreading equipment with a suitable chemical cleaner before using for other purposes (or do not use same spreading equipment for other purposes). Dispose of rinsate according to "Disposal" instructions found under "Storage and Disposal" heading. Do not use on croplands or any land to be used for subsequent cropping. Keep animals off treated areas
