Weed Blast 4-G is a non-selective herbicide for controlling a wide range of annual and pereinnial weeds and grasses. It is recommended only for noncropland areas such as railroad, utility and highway rights-of-way and industrial areas. 200 to 400 pound applications of Weed Blast 4-G per acre usually result in a non-productive condition of the soil for a period of a year or more. The duration of non-productivity is dependent upon rainfall, soil type and other conditions.

Weed Blast 4-G should be applied as furnished with a seed spreader, a fertilizer spreader, or with any equipment which will distribute the chemical uniformly over the area to be treated. For the control of annual and most perennial weeds and grasses, apply Weed Blast 4-G at the rate of 200 to 400 pounds per acre; on small plots 1/2 to 1 pound per 100 square feet. Repeat spot treatment may be required when deeprooted perennial weeds are present. To obtain the best results, Weed Blast 4-G should be applied to the ground where it will be absorbed by the roots. Applications made early in the season have been found to give results superior to applications at a later seasonal date. Weed Blast 4-G may, however, be applied at any time of the year except when the ground is frozen. Maximum effectiveness in and regions is obtained when application is made just prior to the rainy season. Users should consult

state agricultural experimental stations or extension service weed specialists for recommendations as to use in their particular area.
