Subject: Weed Blast 4-G Weed Killer EPA Registration Number 34913-19 Application dated August 20, 2003

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended is acceptable, provided you make the following changes before you release the product for shipment.

1. Remove the word "Prohibitions" under STORAGE AND DISPOSAL

2. Under STORAGE AND DISPOSAL add a subsection "Pesticide Storage" with corresponding text, before "Pesticide Disposal."

3. Under "Applicators and other handlers must wear," change waterproof gloves to "chemical resistant gloves made of any waterproof material."

4. Add the phrase "Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application."

5. Change order of PRECAUTIONARY STATEMENTS to match order of FIRST AID statements, and so that the most severe routes of exposure are listed first.


6. Add a section called User Safety Recommendations, with the following information:

"Users should wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet." "Users should remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing."

Submit three (3) copies of final printed labeling incorporating the above changes before you release the product for shipment. Amended labeling will supercede all previously accepted ones. A stamped copy of labeling is enclosed for your records.


Weed Blast 4-G is a nonselective herbicide for controlling a wide range of annual and perennial weeds and grasses. It is registered for industrial use only such as railroad, utility and highway rights-ol-way. 200 to 400 pound applications of Weed Blast 4-G per acre usually result in a nonproductive condition of the soil for a period of a year or more. The maximum use rate of Weed Blast 4-G is 600 lbs. of product per acre per year or 1.3 lbs. per 100 square feet per year. The duration of nonproductivity is dependent upon rainfall, soil type, and other conditions.

Weed Blast 4-G should be applied as furnished with a seed spreader, a fertilizer spreader, or with any equipment which will distribute the chemical uniformly over the area to be treated. For the control of annual and most perennial weeds and grasses, apply Weed Blast 4-G at the rate of 200 to 400 pounds per acre; on smaller plots, 1/2 to 1 pound per 100 square feet. Repeat spot treatment may be required when deep rooted perennial weeds are present. To obtain the best results, Weed Blast 4-G should be applied to the ground where it will be absorbed by the roots. Applications made early in the season have been found to give results superior to applications at a later seasonal date. Weed Blast 4-G may, however, be applied at any time of the year except when the ground is frozen. Maximum effectiveness in and regions is obtained when application is made just prior to the rainy season. Users should consult state agricultural experimental stations or extension service weed specialists for recommendations as to use in their particular area. Not to be used in any recreational areas or in or around homes. May not be used to treat berms of ditches, seasonally dry flood plains, deltas, marshes, swamps, bogs, and transitional areas between upland and lowland sites

ENTRY RESTRICTIONS

Do not enter or allow others to enter the treated area until dusts have settled
