The Agency is in receipt of your Applications for Pesticide Notification under Pesticide Registration Notice (PRN) 2007-4 dated August 10, 2010 for:

EPA Registration 34913-15 SprayKil SK-13 Granular Weed Killer EPA Registration 34913-16 SprayKil SK-26 Granular Weed Killer EPA Registration 34913-20 Weed Blast 4-G Weed Killer Weed Blast 8-G Weed Killer EPA Registration 34913-22 Topsite 2.5G Herbicide EPA Registration 34913-23 Arsenal 0.5G Herbicide

The Registration Division (RD) has conducted a review of this request for applicability under PRN 2007-4 and finds that the label changes requested fall within the scope of PRN-2007-4. The label has been date-stamped "Notification" and will be placed in our records.

Please be reminded that 40 CFR Part 156-140(a)(4) requires that a batch code, lot number, or other code identifying the batch of the pesticide distributed and sold be placed on <u>nonrefillable</u> containers. The code may appear either on the label (and can be added by non-notification/PR Notice 98-10) or durably marked on the container itself.



NON-CROP WEED CONTROL INDUSTRIAL USE ONLY

Weed Blast 8-G is a nonselective herbicide for controlling a wide range of annual and perennial weeds and grasses. It is registered for industrial use only such as railroad, utility and highway rights-ofway, and industrial areas. 100 to 200 pound applications of Weed Blast 8-G per acre usually result in a nonproductive condition of the soll for a period of a year or more. The duration of nonproductivity is dependent upon rainfall, soil type, and other conditions. Application with a spoon, a pump-feed backpack spreader or a gravity-feed backpack spreader is prohibited.

Weed Blast 8-G should be applied as furnished with a seed spreader, a fertilizer spreader, or with any equipment which will distribute the chemical uniformly over the area to be treated. For the control of annual and most perennial weeds and grasses, apply Weed Blast 8-G at the rate of 100 to 200 pounds per acre; on smaller plots, 1/4 to 1/2 pound per 100 square feet. Repeat spot treatment may be required when deep rooted perennial weeds are present. The maximum application rate of product that may be applied is no more than 12 lb. al/A per year or a total of 300 lbs. of product per acre per year. To obtain the best results, Weed Blast 8-G should be applied to the ground where it will be absorbed by the roots. Applications made early in the season have been found to give results superior to applications at a later seasonal date. Weed Blast 8-G may, however, be applied at any time of the year except when the ground is frozen. Maximum effectiveness in arid regions is obtained when application is made just prior to the rainy season. Users should consult state agricultural experimental stations or extension service weed specialists for recommendations as to use in their particular area. May not be used to treat berms of ditches, seasonally dry flood plains, deltas, marshes, swamps, bogs, and transitional areas between upland and lowland sites.

Maximum rate per application:

- · 12.0 pounds diuron active ingredient per acre in areas of high rainfall or dense
 - vegetation.
- 8.0 pounds diuron active ingredient per acre in all other areas.

Apply a maximum of two applications per year. Minimum retreatment interval: 90 days.

The requirements in this box apply to uses of this product that are NOT within the scope of the Worker Protection Standard for agricultural pesticides (40 CFR Part 170).
